

This Indenture made this 17th of Feb^ry 1802 between Sam^l Brown
 known of the County of Cabarrus State of N^o Carolina of the
 one part & Sam^l Jamison of the place of the other Witnesses
 that for & in consideration of the sum of \$100 dollars in
 hand paid the rec^d whereof is hereby ack^d & therefor the
 sd Sam^l Jamison doth hereby grant bargain & sell
 unto the sd Sam^l Brown a certain tract of land
 lying in the County of Mecklenburg & State on the
 forks of Rocky River Beginning at a B.O. on the River
 of Rocky river runs thence N 72 E 60 ps. to l^o l^o. then N 48 E
 - 26 ps to B.O. then N 79 E 60 ps to P.O. on the bearing line
 then with sd line S 22 W 40 ps to W.O. the W. corner then
 N 65 W 8 1/2 ps to Hickory then N 37 W 102 ps to B.O.
 then N 2 E 70 ps to the Beginning containing by survey
 167 acres more or less conveyed to sd Sam^l Brown by Deed
 Copland by deed dated 24th of Jan^y 1789 duly of record
 also on other tract of land in sd County on sd Rocky River
 containing 45 acres more or less adjoining the above
 mentioned tract & Beginning at a small Hickory
 corner of the above mentioned tract & runs with the
 line of the same N 37 W 112 ps to a B.O. another
 corner of sd old tract then another of sd old line to
 W. side of river to a large B.O. another corner of sd old
 tract & widow Beavers corner then with her line N 60
 W 60 ps to a W.O. Quab Oliver Harris corner then with
 sd Harris' line S 25 W 48 ps to the river to a Hickory
 on near the s^o ford Spring branch on his line then with his
 line S 53 E 78 ps to a B.O. sd Stafford's corner then with
 his other line S 35 E 62 ps to a Line caplin at sd Stafford
 corner then with his other line S 6 W 37 ps to a B.O. the
 corner then S 13 E 61 ps to B.O. caplin then E 43 1/2 ps to a Stone
 P.O. near McMillians corner then N 77 E 72 ps to a large
 W.O. on the old line then along the same to the sd Hickory
 being a tract of land granted to sd Sam^l Brown by the
 State of N^o Carolina by Grant dated Dec^r 2^d 1799. With the
 apartments lying & being as app^d with this & every of this eight parcels & improve
 ments to him the sd Sam^l Jamison to have & to hold to sd Sam^l Brown & every part thereof
 free & clear of all incumbrances unto the sd Sam^l Jamison his heirs & assigns forever
 And the sd Sam^l Brown doth hereby covenant & agree to & with the sd Sam^l Jamison
 that the sd Sam^l Brown his heirs & assigns shall & will at all times warrant & defend
 the sd Sam^l Jamison his heirs & assigns from all legal claims & demands which
 shall come unto the sd Sam^l Jamison his heirs & assigns for or in a way whereby
 he has limits set any hand & deal the day & year first above written
 signed & sealed & deliv^d as
 Sam^l Jamison
