Family of John Walden Meyers and Mary/Polly Gruber/Kruger 1st child and eldest son of George & Margaretha Waldenmeyer;

b. 24 February; bapt. 24 March 1745 at St. Paul's (Zions) Luth. Ch. of Red Hook; wit.-Leonhard Weger & wife Barbara Wegerin. (George & Margaretha Waldenmeier were wit. at the bapt: of the Weger's dau., Elizabeth, 11 May 1746, also at the Ch. at Red Hook. Are the two families related in some way?)

d. 22 November; bur. 24 November 1821 in the Old Sidney Burying Ground located on Lot 10 in the front of Sidney, overlooking the Bay of

Quinte, Hastings Co., Ont., Can.

Hoffnel, wid. of John Davey, an old friend of John who had d. in 1808 (b. 5 October 1751; bur. 20 May 1808) He had m.(1) Dorothea Schneider and came to Bath, Lennox & Addington Co., Ont., Can., ca. 1784. He had m.(2) 22 November 1787 Sophia Hoffnel. I do not have a b. date for Sophia, but she d. bet. 22 February 1836 (date her will was written) and 22 August 1836 (date the will was registered). She apparently resumed the name Davey after John's death, as

she willed land, as Sophia Davey, to her dau.; Sophia Billings.

Her son, Peter Davey did not d.y., but married and had a large family.

Jane Goddard's book <u>Hans Waltimyer</u> mentions Peter Davey as a young man visiting John Walden Meyers. He was already married with his own family when John married his mother, so was not mentioned in John's will.

John had changed his name to Walden Meyers after the break with his father and brother, Jacob, when he became a Loyalist, and to help escape detection as a Loyalist spy.

For very interesting details of John's life as a Loyalist spy, read <u>The Loyalist Spy</u> and <u>King's Men</u>, by Mary Beacock Fryer.

For more details on his family and life in Hastings Co., Ontario, read Hans Waltimyer by Jane B. Goddard, U.E., a descendant.

In the histories, no mention is made as to when his wife joined him in Canada, but she is referred to as "his jolly, buxom little wife" helping him to offer "hearty hospitality" to all classes of settlers.

He was retired as an officer of the British army. He kept a number of slaves, as did many pioneers of Upper Canada.
