- IV. Katherine/Catherine Walden Meyers was still alive in 1833 when she shared with her brother, James, and sister, Rachel, the front of Lot 21, Conc. 3 (Sidney? or Huntington?). Her sister, Ann/Nancy Brown had the rear in 1825-1827. I believe Catherine is the one who m. by 1829 her 1st cousin, John G. Walden Meyers, son of George.
