Obit. of John Row, Sr. from the <u>Canada Christian Advocate</u>, 22 July 1857, reads, "John Rowe, Sr., was b. in Duchess Co., NY, and went to Nova Scotia in boyhood, then to sea. Nearly 64 yrs. ago he settled in Sidney Twp. He d. at the residence of his son, John, in that twp. 24 May 1857, age 83; survived by his wife."

His will was dated 28 January 1850; reg. 13 July 1867. He willed the Ex of Lot 11, Conc. 2 to John Row and the Wz to Susanna Potter. Was she a gr.dau.?

Salt Lake City, UT.) An indenture dated 11 January 1868 stated
that his wid., Eliza, and 5 children survived:

William's father, Tobias, had willed 400 acres of land he owned in Elzivir, on which they were now living, to children of his son, William, by his wife, Jeannette.

- 3. Mary Bleeker, eldest dau. of William Bleeker, Esq., d. 23 September 1872, age 20y.3mo. (W.I.)
- 4. Herman Bleeker was ment. in his mother's will, but not his father's, so perhaps he d. bet. 1881-1910.
- 5. Frederick Bleeker (1861-1891 census) Mary Bragg, wife of Frederick Bleeker, d. 4 April 1900, age 36, in Belleville; bur. 6 April 1900 at St. Thomas Anglican Ch., Belleville, Ont. Her husband, Frederick Bleecker, was then living in the U.S., where he had lived for a number of years, separated from his wife, in the City of Detroit, MI. When her mother, Sarah Bragg, as adm. of her estate (Hastings Co. Surrogate Ct. #2433-1900) was informed that Mary's husband was her legal heir, Sarah produced a deed of legal separation dated 23 March 1891. In the 1891 census Mary was in her mother's hshld. and Frederick was in the home of his sister, Ella. Mary was in 1881-1891 census. Apparently there were no children. Frederick was named in both his mother's and his father's will.
- 6. William <u>Lewis</u> Bleeker, son of William Bleecker, Esq., d. 11 October 1872. Called Lewis on 1871 census.
- 7. Donald Gilbert Bleeker (V.I, p.49, says he was unmarried, but he must have m. later, as his wid. was still living in 1928.)
- 8. Ellen/Ella Tweedale Bleeker (not Ella J.) was still alive, unmarried, in 1935. She was named in both her mother's and her father's will.
- 9. William Bleeker b. ca. 1890; d. (1891 census) He was named in his father's will.
- 10. Benjamin Seymour Bleeker b. ca. 189\_?; d. He was named in his father's will.
- C. Jane Bleeker d. 23 February 1918 in Belleville. Her dau., Emma Carrier, wid., of Toronto, was her execx. The only other heirs ment. were the children of her son, Ellis Bleecker Burrell, for whom she had set up a trust fund. (Hastings Co. Surrogate Ct., Will #5636, dated 11 February 1911; pro. 23 June 1919.) (1861-1891 census)

- C. Jane Bleeker's husband, Ellis Burrell d. 14 March 1882 in Belleville (Hastings Co. Surrogate Ct. #738-1882) (1861-1881 census) His will didn't name his wife, but made her guardian of their 3 "inf." children. The other children were adult. He was very well-to-do, as he had much property, including factories. Children:

- 8. Susan Helen Stapley b. ca. 1870; d. (1871-1891 census)
  m. after 1891 Robert Marshall b. ; d. (There is a Susan, age 1, in the 1871 census; in 1881, she is Helen, age 11; in 1891 she is Susan, age 21; so I believe her name is Susan Helen.
- F. John James Flint Bleeker was identified at the adm. of his estate in 1946 as John James Bleeker Flint, the name by which he was later known as a lawyer and police magistrate in Belleville, Ont. He was identified as son of Tobias in his will dated 27 August 1866—called John J. Bleeker Flint. He was apparently raised in the family of Billa Flint after his mother died, and took the name Flint. He prob. d. ca. 1946, as Dougall Lawrence Bleeker was trustee of his last will and testaments and codicils on 8 October 1946. (1851—1891 census) He m. 14 September 1866 Eliza J. Holton, only dau. of Ezra W. Holton, Esq.; b. ca. 1840; d. (1871—1891 census) Children: (Apparently none.)
- G. Louisa Bleeker is identified as Margaret Louisa Bleeker in her father's will, as wife of Samuel Danford/Danforth. (Danford on m. rec. amd in censuses) She is called Louisa in all censuses except 1861, when she is called Margaret in the home of her ½ bro., William Ripson Bleeker.

    In 1891 Samuel Danford moved to Madoc Twp. from Rawdon (The article says Thurlow, but he lived in Rawdon from 1871-1891 census) to establish woollen mills. (See Fabric of a Dream, by Brenda Hudson, pp. 33-36) Both Sam and his wife, Louisa, d. in 1935. Their son, Joseph, and his son, Sam, continued the business.

She was identified as dau. of Tobias in his will. She was also ment. in the adm. of the estate of her sister, Catherine Matilda Farley.
