1. ABEDNEGO<sup>1</sup> BAKER was born 19 August 1818 in Coshocton Co., Ohio, and died 13 April 1885 in Linton Mills, Coshocton Co., Ohio. He married RACHEL BAKER Abt. 1836 in unknown. She was born 16 June 1812 in Virginia, and died 12 September 1880 in Lafayette Twp., Coshocton Co., Ohio.

## Ancestry of Rachel Baker Baker

The name of John D. Baker's mother was recorded on death certificate as Rachel Baker. Initially this was interpreted as her married name. The deed of 26 November 1845 (Vol. 20, p. 350, Coshocton County Deeds) between Abednego Baker and Charles Baker, of Coshocton County, Ohio, shows wife of Abednego as Rachael. In addition, this quitclaim deed proves that Rachael's maiden name was also Baker. She was a daughter of the late Abednego Baker

and his unknown wife. The deed, signed by Abednego and Rachael (their marks) releases Rachael's share of land under Esaias Baker's will to Charles

Baker for the amount of \$20.00. See bequests in the Will of Esaias Baker, dated 12 June 1841. Quit claim deeds were also executed between Charles and the other two children of Abednego and unknown. These deeds released for the sum of \$20.00 each paid to John and Sarah Baker White and Isaiah and Lucinda Haught Beverlin Baker their shares of real property under the terms of Esaias Baker's will to their uncle, Charles Baker. Both Sarah and Isaiah lived in Tyler County, Virginia.

Will

In the name of the benevolent Father of all, I, Abednego Baker, give and devise to my Son, John D. Baker and his heirs the following real estate situated in Linton Township, Coshocton County and State of Ohio, namely thirty-three acres of land of the east end of Lot No. 19, Township (4) Range (4) Section (3) U. S. Military Land.

I devise and bequeath to my Daughter Sarah O. Baker, the following real estate situated in Township County Range and Section above mentioned thirty three acres direct west of above mentioned thirty three acres.

I also give and devise to my daughter Mary Elizabeth Gaumer and her heirs the following real estate situated in township County Range and Section above mentioned thirty-five acres direct west of above mentioned tract making all together one hundred acres of land now owned by me in Lot No. 19, township (4) Range (4) and section (3) described as United States Military Land.

I hereby nominate and appoint Edgar G. Abbott executor of this my Last will and testament hereby empowering and authorizing him to compromise adjust release and discharge in such manner as he may deem proper the debts and claims due me.

I desire that no appointments or sale of my personal property be made and that the Court of Probate direct the omission of same in pursuance of the Statute.

In testamony hereof I have hereunto set my hand and sale this eighth day of June one thousand eight hundred and eighty one.
