My Mother's Ancestors

by Mary Walker Blanton (Mrs James M. Wharey)

John SMITH married Susannah WATSON whose mother was a Miss ALLEN, and lived near Rice, Prince Edward County, Va. To them were born three sons: Allen, Thornton and Sterling; and two daughters, one of whom married Mr ATKINSON of Amelia County, Va. They had two children, Sterling and Mary, who married Miles GILLS of Amelia County, and became the mother of a large family.

My grandmother Mary Anne SMITH married Capt Wm WALKER of "High Hill," Cumberland County, Va., and became the mother of seven sons and two daughters.

Capt Wm WALKER was born at "High Hill," Cumberland County, Va. on 22 Feb 1757, and died at his residence "Airy Green" in Cumberland County, August 1840. He was the son of Warren WALKER and Magdalene BURTON, and grandson of William and Judith (BAKER) WALKER of Southam Parish, Va. Capt Walker had a brother Warren and two sisters, Mrs Judith MEREDITH and Mrs Polly LeGRANDE of Buckingham County, Va. Capt Walker served in the Revolutionary War. He was a large land owner. His eldest son, John, married Miss BERRYMAN. To them were born two children: Susan, the eldest, married Joseph BLANTON of Cumberland County, Va. and to them were born eight children:

The only son of John WALKER, William Anderson, married Mary Walker BLANTON and to them was born one child, Mary Ann Letitia, who died in infancy at my father's home.

The second son of Capt and Mrs Walker was William Baker Burton. He married first Frances BLANTON (my father's sister) and to them were born two sons and one daughter. William Davis WALKER (the eldest) married first Ellen CROWDER, and second Margaret CROWDER. By the first marriage there were a number of children, one of whom married Maria BOLLING of Cumberland County. John, the second son married Miss Harriet COURTNEY of Richmond, Va. They were childless. The daughter, Mary Ann THORNTON, married Lenoson MORRISETTE of Chesterfield County, Va. They had several children.

Capt and Mrs Walker's eldest daughter, Karenheppuch (b 1786) married Mr William LIGON of Amelia County, Va. Their children were William Warren LIGON; Robert LIGON who moved to Texas; Ann Jane LIGON married my uncle Reuben BLANTON; Elvira LIGON married Mr PARKINSON; and Louisa LIGON married my brother Walker BLANTON.

The second daughter of Capt and Mrs Walker was Mary Ann Susannah Smith. She married Mr Henry HINES and removed to Bowling Green, Ky. They had several children.

Capt and Mrs Walker's daughter, Elizabeth, married first Mr James MILLER of Powhatan County, Va. One child was born and died in infancy. Elizabeth MILLER married second Mr John JOHNS of Cumberland County, Va. and had one daughter, Mrs Mary WREN of Salisbury, N.C.

The fourth daughter of Capt and Mrs WALKER was Sally who married John MILLER and lived in Tennessee. They were the parents of three children: Ann, who married Edward BLANTON and became the mother of a large family, several of whom live in Richmond, Va.; William; Allen married a Miss FOWLKES of Nottaway, Va. They had three children; Ann who married Adolphus BLANTON and Sallie who married Barksdale BLANTON; Thomas died young.

Capt and Mrs Walker's fifth daughter, Virginia, married Mr Elijah MEGEHEE and removed to Henry County, Tenn. They had a large family.

The sixth daughter of Capt and Mrs Walker was Nancy Thornton WALKER, my mother. She married Mr James BLANTON of Cumberland County, Va. and lived near Brown's Church. They were married Dec. 2, 1818. To them were born ten children: William David; Mary Walker I; Philip Southall; James Madison; Walker Burton; Francis Baker; Judith Thornton (burned to death at school at age 11 years); Benjamin Watkins Leigh; Martha Wilson died at age 2 years; and Mary Walker BLANTON II who married first Mr William OVERTON, and second James Morton WHAREY, D. D.

The seventh daughter of Capt and Mrs Walker, Rebecca, married first Lindsay BLANTON (my father's brother). To them were born Rev William Lindsay BLANTON; Elizabeth (Mrs James WALTHALL) of Prince Edward County, Va.; Judith (Mrs FRENCH of Richmond); Rebecca, married the second time Mr CALDWELL of Connecticut and lived in Amelia County, Va. They had several children. Mary married Thomas JETER of Amelia County. Jennie married Mr WILKINSON of Chesterfield County, and had two sons who died early in life.

My Grandfather Walker was a Baptist but his father, Mr Warren WALKER of "High Hill" was a staunch Presbyterian. My grandmother Walker's family (the SMITHS) were all Baptists.

My Grandmother Blanton was a Presbyterian. My Grandfather Blanton was not a member of any church. Uncle Willis BLANTON was a Methodist. Lindsay was not a member of the church. His wife was a Baptist. Reuben's family were Methodists; Joseph's Presbyterians; James' Presbyterians; Uncle William WALKER a Baptist, and all of my Mother's sisters were Baptists, except Elizabeth who married a Presbyterian, Mr JOHNS.

My Grandfather David BLANTON's mother was a Miss ANDERSON from Caroline County, Va. I do not know his father's name. David BLANTON married Lucy JOHNS, daughter of James JOHNS of Cumberland County, Va. She had a brother Rueben JOHNS whose descendants live in Buckingham Courny, Va. My Grandfather David Blanton settled near Brown's Church on the farm later owned by Walker BLANTON's children. There was a large family. The eldest son Anderson Tinsley BLANTON left three sons: Alexander Monroe BLANTON; Edward Anderson BLANTON; and George Vawter BLANTON.

The second son of David and Lucy Blanton was my father, James BLANTON (born 1796) who married 23 Nov. 1818 Nancy Thornton WALKER, Cumberland County, Va. They had six sons and four daughters.

William David BLANTON the eldest born 2 Oct 1819 married Rebecca LEE and to them were born twelve children: Erastus Lee BLANTON; Joseph BLANTON; Willis Southall BLANTON; Ann Sophia; Judith (Mrs BASKERVILLE); John Wilson BLANTON; Wm. Blair BLANTON; Nannie (Mrs MARTIN); Frank BLANTON; Jesse Armistead BLANTON; Mary Walker and Sarah Elizabeth BLANTON.

The second son of James Blanton and Nancy Walker was Philip Southall (M.D.) born 30 June 1824. He married Nannie ARMISTEAD daughter of Rev Jess ARMISTEAD, D.D., noted Presbyterian minister of Virginia. To them were born Truehart; Jessie (Mrs Wm. JOHNSON) of Amelia County, Va.; Prescott who married Kate FARRIS of Montgomery, Ala. Philip died in infancy. Dr. Charles Armistead BLANTON of Richmond, married Bessie WALLACE of Richmond Va.; and Maria PAGE.

The third son of James and Nancy Blanton was James Madison, M. D., born 30 July 1826. He married Sarah LEE and to them were born eight children: M Barksdale BLANTON; Sally Reed (Mrs Wm VAUGHAN); Nannie Thornton (Mrs Sam BADGETT); Mary Lee (Mrs Adolphus BLANTON); Robert Lee BLANTON; and three who died in infancy.

The fourth son of James and Nancy Blanton was Walker Burton who was born 20 June 1828. He married first Lavinia LIGON and to them were born Botts BLANTON; Ida; Karen; Stuart BLANTON; and Ligon BLANTON. His second wife was Jennie BLANTON of Farmville, Va.

The fifth son Francis Baker BLANTON was born 1 April 1831. He married Eliza Diell, daughter of Rev John DIELL of the Sandwich Islands. To them were born John Diell BLANTON of Nashville, Tenn.; James Platt BLANTON; Anna Lee (Mrs Owen McCLURE of Missouri); and Dr J. Clary BLANTON of Henrico County, Va. Carrie Thornton BLANTON died in her teens; two sons died when small.

The sixth son Benjamin Watkins Leigh BLANTON was born 28 July 1836. He married Virginia Leigh WICKER of Richmond, Va. whose father, Francis LEIGH was at one time Mayor of Richmond. To them were born nine children: Lucy Thornton (Mrs Robert HAGAN); Eudora (Mrs OVERBY); James Francis BLANTON of Huntington, W. Va.; Mrs Lena HASKINS of El Paso, Tex.; Mrs Nettie SEAMOUR, El Paso, Tex.; Mrs Carrie HENLEY, Huntington, W. Va.; Oscar S BLANTON of El Paso, Tex.; and Benjamin BLANTON of Richmond, Va.

Mary WALKER, eldest daughter of James and Nancy BLANTON was born in 1821. She married William Anderson WALKER; died at age 17 years, left one child, a daughter who lived two years.

Judith Thornton BLANTON was born in 1833; burned at school at age 11 years. Martha Wilson BLANTON died at age two years.

Mary Walker II was born October 21, 1842; married William S Overton in October 1867. To them was born one son William Swepston OVERTON of Salisbury, N. C.

Mary Walker OVERTON married Rev James Morton WHAREY, pastor of the Cumberland Presbyterian Church, July 1868. To them were born five children: Nannie Morton (Mrs W. R. GREY, Jr. of Davidson, N. C.); James Blanton WHAREY, Ph.D. of the University of Texas; and Bessie Blair (Mrs C. L. GREY of Davidson, N. C.) Two children died in infancy.

My father, James BLANTON, was born near Brown's Church in Cumberland County, Va., March 8, 1796; died 23 February 1852.

My mother, Nancy Thornton WALKER was born at "Airy Green" in Cumberland County, Va. She died at Mooresville, N. C. on September 9, 1881.

My father was a large land owner; was Justice of the Peace in Cumberland County, and revered by all who knew him, a fine business man. At Farmville, Va., in partnership with his brother Willis Blanton. He was a member of the Presbyterian Church; was a Whig in politics; was not in the army but belonged to a Militia Co., as well as Citizens' Club of his day.

The Blantons are of English descent. Rev Adolphus FRENCH of the First Baptist Church at Eufala, Ala., has a Family Tree prepared by his mother Mrs Judith FRENCH of Richmond, Va.

The third son of David and Lucy Blanton was Willis BLANTON who lived in Farmville, Va. He married first Martha LIGON, my mother's niece of Amelia, and had a son Thomas of Cumberland; and Martha Willis BLANTON (Mrs James WALTHALL of Prince Edward County, Va.). His second wife was Elizabeth JETER of Amelia, Va., and to them were born Mary Blanton (Mrs Chesley WOOD of Texas; Mrs C. C. LOCKETT of Pasadena, Cal.; Nannie (Mrs Thomas MORTON of Farmville); Jennie (Mrs Walker BLANTON of Cumberland); and Mrs Edward HUGHES of Farmville.

David and Lucy Blanton's fourth son was Lindsay BLANTON. He married Rebecca WALKER (my mother's youngest sister.) They were the parents of Rev Thomas Lindsay BLANTON, a Methodist Minister; Elizabeth BLANTON (Mrs James WALTHALL of Prince Edward); Judith BLANTON (Mrs John FRENCH) of Richmond, Va.

The fifth son of David and Lucy Blanton was Joseph, who married my mother's niece Susan WALKER. To them were born Dr. John William BLANTON; Rev Lindsay Hughes BLANTON; Daniel L. BLANTON; Camilla BLANTON (Mrs Dr Hugh BLANTON); Anne BLANTON (Mrs GRIGG); Morton BLANTON: and Joseph BLANTON II.

The sixth son, Reuben, married in 1827, my mother's niece Ann Jane Elizabeth LIGON of Amelia. Their children were Martha Ann (Mrs Jeff GREEN) of Amelia; Rebecca BLANTON (Mrs JOHNSON of Amelia); William BLANTON; James BLANTON; Robert BLANTON; Lucy BLANTON (Mrs James HILLSMAN); Mary BLANTON (Mrs Dr HILLSMAN of Richmond); Lavinia BLANTON (Mrs Robert BALDWIN of Farmville.)

David and Lucy Blanton's eldest daughter Judith, married Mr William ARMISTEAD, first, and was the mother of James M and William ARMISTEAD of Richmond and Mrs Lucy McGEHEE of Amelia County, and grandmother of Mrs Nannie CRUMP of Richmond. She married the second time Mr Phaup of Cumberland, no children.

Frances BLANTON, the second daughter of David and Lucy Blanton, married William Baker Burton WALKER of Cumber land, and to them were born three children: William D. WALKER; John WALKER; and Mollie (Mrs MORRISETTE of Chest Chesterfield County.)

I believe this covers the immediate family record.

This paper was prepared by Mary Walker Blanton (Mrs James D. Wharey) when she was about 85 years of age.

The BLANTON-WALKER "Wharey Paper" written in her 85th year by Mary Walker BLANTON WHAREY, born 21 Oct 1842, Cumberland County, Va is the document upon which this outline of the Cumberland County, Prince Edward County, and Amelia County Virginia Blanton Families, is based.

Cumberland County, Va was formed 1749 Court House, Cumberland, Va Prince Edward County, Va was formed 1753 County Seat, Farmville, Va Amelia County, Va was formed 1734 County Seat, Amelia, Va

In his HISTORY OF CAROLINE COUNTY, VIRGINIA, published 1925, Dr Marshall Wingfield, Clergyman and Historian, born 19 Feb 1893, Franklin County, Va, reports that

"John BLANTON married Hannah ANDERSON of Caroline County; in 1749 removed to Cumberland County, and settled near Brown's Church."

At about the time John Blanton married Hannah Anderson, it so happens that Richard BLANTON married Johana SNEAD/SNEED of Caroline County, Va. The identity of Hannah ANDERSON has been confused with that of Johana SNEAD.

Johana Snead's mother was a Miss CARTER. Johana had brothers Israel and Alexander SNEAD. Johana's sisters were:

Ruth who married Mr MUNDY Mollie who married Charles BROWN Lucy who married Benjamin NEWTON; and a sister who married Mr REDD.

Richard Blanton and his wife Johana Snead, had a son Carter BLANTON b 1765 Virginia, who married 1787 Susannah SNEAD, in Caroline County, Va. Carter Blanton and his wife died and are buried near Frankfort, Ky.

A thorough search of all available records of the Commonwealth of Virginia, and those of Kentucky, proves that Richard BLANTON born around 1720 (was Sheriff prior to the Revolutionary War) died in Kentucky, is buried in Grassy Springs Churchyard, near Glenn's Creek, about twenty miles south and east of Frankfort, Ky.

John BLANTON who married Hannah ANDERSON lived in Cumberland County, Va, about eight miles north of Farmville, which is in Prince Edward County, and left four known sons. They were:

Abstracts from a letter dated 11 Feb 1957, Cumberland, Va.

- ". . . I will undertake to tell you all I have ever heard about the Blantons. My mother said it was three Blanton brothers from England and JOHN the 1st settled in Cumberland County, about 12 miles from Farmville, and his place has always been called "High Hill." There are many graves at "High Hill" but only two stones . . .
- ". . . My father's mother and my mother's mother were sisters, daughters of John SMITH.
- ". . . My father John James BLANTON was born 20 June 1848 at "High Hill," Cumberland County. In 1870 he married my mother Laura Pope BRIGHTWELL born 19 July 1854.

"Twin boys were born 1875, they did not live. Then there were four girls and 2 boys: Fannie V; Ada H; Allie J; and Laura Pope Blanton born 31 Dec 1886 Cumberland County, Va. The two boys were Josiah Brightwell Blanton; and John Richard Blanton. A younger boy Charlie lived only a few months.

My father was Postmaster of Guinea Mills, then I got the appointment in 1915 and was Postmaster until Oct 31, 1955. I was seventy years old on Dec 31, 1956. I have a small picture of my house. If I ever dig it up again will send it to you . . .



I think I should perhaps start this paper with a brief account of how I have happened to come by the facts. I shall of course state the sources, but a statement will help other people to evaluate what I have collected.

I married Smiley Blanton in 1910. His father was still living. His mother died when he was three, and his father married his aunt, whom we called Amnie (Auntie). She had lived in the same community all her life, and she had, of course, known many of the Blantons.

She was paralyzed, and bedridden, and had nothing to think about but the past. For several summers we went back to Nashville for the holidays (from Cornell). When Smiley graduated from Cornell Medical in New York we got a job in Wisconsin, and took her out there. She was lonely and out of the stream of life, so I made it a custom to go sit with her for an hour or two daily. The easiest thing for us to talk about, and the thing that interested her the most, was family history. I recorded all she told me, but often not in the correct order, or correctly connected. In time I was able to correlate most of it.

In addition to this source, Smiley's father, Hiram Harris Blanton, was there. He knew relatively little of the things that go to make up a family history: who married Cousin---etc.

He had a brother Jack Crisp Blanton of whom I was very fond. He lived "down in the bend." He fought through the war, and told many tales of it to which I listened unendingly and with delight. He gave me the desk of red-cherry made by his father.

There was a sister Lucy whom I knew slightly. She was the wife of Dr. Manier and lived at Tullahoma.

There was a brother (WL) of the Pater's (HHB) in Texas with whom I corresponded, and later a second one (GW), and later a nephew (Jeptha) and another one who gave me some facts.

Amnie died during the flu epidemic of 1918 and the Pater remarried and went to live in Birmingham. I saw him at holidays then, but he was never able to add much to my knowledge.

There was a family bible of William Crisp Blanton. There was a sword (I gave it to Tenn. Historical).

The family bible is not very extensive, and I shall give the data from each name in it, and then add the data that I have collected from various sources, giving the source if I know it, or if it seems important. If I have time I shall add some pages of the tales I was told about the things they did in Unionville.

This is very remote, gathered most of it 40 odd years ago, and never checked on because I had no need to do it, nor any way to. It is good only as a guide and for suggestions to anybody who wants to hunt.

Declaration of Surviving Soldier for Pension under Act of 14 Feb 1871, was made on 1st day of August 1871, State of Tenn, County of Rutherford, at which time Meredith Blanton stated that he was aged 79 years, a resident of Unionville, Bedford County, Tenn. He served in Capt Allen Wilson's Company, Col Truhart's Regiment, Gen Chambers Brigade. Was drafted at Cumberland Court House, Va on the 28th day of August 1814, and was honorably discharged at Richmond, Va on the 1st day of December 1814, and has received two land warrants, amounting to 160 acres in all.
- Deed Bk CC p 225 Bedford County, Tenn. Meredith Blanton buys for \$5.25, three and one-half acres of land from Wm Ogilvie on 14th Feb 1832. It is called "a parcel of land at Thompson's Ford Road, near Union Camp Ground." An article in the Unionville newspaper says the blacksmith shop of Meredith Blanton was built in 1828, and a house was built in 1832. The old Blanton house was standing in the early 1950's. Meredith Blanton was a Blacksmith and a Carriagewright. His sons Elisha and Wm Crisp worked with him, as did eventually his grandson John "Jack" Crisp Blanton. Meredith Blanton was quite tall, had dark hair and dark eyes. He was also a Magistrate and rode from Court to Court on a very small horse.

Tradition says that Meredith and Nancy came to Tennessee in an Ox Cart Train from "near the Carolina line" Mecklenburg County, Va.

The will of Meredith Blanton is in Shelbyville, Tenn, dated 22 Sept 1871, probated August term 1879. He leaves his entire estate to women--wife, daughters, daughters-in-law, and granddaughters.

There is a tradition that Meredith Blanton was one of seven brothers. One brother migrated to Mississippi, and one brother to Missouri.

There is also a tradition that Meredith had a "first double cousin" named Ben Blanton, b 1802, to whom Meredith was devoted. The two were always very close, and are buried together on the same lot in the Churchyard at Unionville, Tenn.

D. one thousand eight hundred and seventy one personally appeared before me a court of record in and for the county and State aforesaid, Meredith Blanton aged seventy-nine (79) years, a resident of Unionville, County of Bedford, State of Tennessee, who being duly sworn according to law, declares that he is married; that his wife's name was Nancy Crisp, to whom he was married on the 7th day of April, 1814, at Cumberland Co. Virginia: that he served the full period of sixty days in the military service of the United States in the war of 1812; and who was the identicle Meredith Blanton who was drafted in Captain Allen Wilson's company, Col. Truehart's regiment, Gen'l Chambers? brigade, division, at Cumberland C. H. Va. on the 28th day of August, 1814, and was honorably discharged at Richmond, Va., on the 1st day of December 1814; that he was stationed in New Kent Co. 18 miles below Richmond, Bottom's Bridge most of the time he was in the service. He has received two land warrants, amounting to 160 acres in all.

That, at no time during the late rebellion against the authority of the United States, did he adhere to the cause of the enemies of the Government, giving them aid or comfort, or exercise the functions of any office whatever under any authority, or pretended authority, in hostility to the United States; that he will support the Constitution of the United States; that he is not in receipt of a pension under any previous Act;

That he makes this declaration for the purpose of being placed on the pension roll of the United States, under the provisions of the Act approved February 14, 1871; and hereby constitutes and appoints with full power of substitution and revocation, Leland Jordan, his true and lawful attorney, to prosecute his claim and obtain the pension certificate that may be issued; that his post-office is at Unionville, County of Bedford, State of Tennessee that his domicile or place of abode is at the same.

WILLIAM CRISP BLANTON was a Col of Militia, became Capt of Co A of the 23rd Tennessee; later known as Co C, and later still, Co F, organized July 1861. The sword of William C Blanton is with the Tennessee Historical Commission, Nashville, Tenn. William Crisp Blanton was Postmaster from March 1851 to April 1854, and was appointed again June 1856 to April 1858. He was also a Tax Collector. His occupation as shown in 1850 Census Bedford County, Tenn is that of "Coachmaker." William C Blanton had ten children. They were:

On January 31, 1955, Mr Jeptha W Blanton, Sr., of Dallas, Texas wrote:

"After the Civil War, or in 1870, Uncle Pete Wallis who had previously moved to Texas and was living at McKinney, came to Bellbuckle, Tennessee, as he knew my father, Elisha Albert Blanton, was contemplating a move to Texas. Uncle Pete piloted us to Texas, all of us coming in two horse covered wagons. It took us 30 days to come from Bellbuckle to a little town near McKinney, then known as Orangeville. Here it was that my father and mother taught school for two years. Father thought he could find a better place to live, as he wanted to practice his profession—that of a lawyer. We moved to Gainesville in 1872."
