JOHN BLANTON residing in #117,1790 Rutherford County, North Carolina is undoubtedly one and the same "John Blanton" as the John Blanton who was previously in Burke County, North Carolina, and on August 1, 1786 bought from Wm BASSETT a parcel of land in Rutherford County, "lying and being on both sides of Main Broad River."

Further identity of "John Blanton of Burke County, N.C. 1786; Rutherford County, N.C. 1790" has not been established. Neither have the "three sons born between 1774-1790 been identified." There is a strong tradition among the North Carolina Blanton families that "JOHN Blanton was the father of the Second GEORGE BLANTON." In all probability "John Blanton of Burke County, and of Rutherford County, N.C." had a son named GEORGE, who is one and the same "George" as was residing in 1840 Spartanburg Co. S. C. REUBIN BLANTON is thought to have had a son named JOHN. REUBIN and many of his descendants finally settled south of the NC-SC boundary line. The last Will and Testament of GEORGE BLANTON, Commissioner of Peace, names four sons, one being JOHN. There is good evidence that GEORGE's son JOHN, migrated to middle Tennessee prior to 1820.

Patent dated 25 April 1767, granted to said Wm BASSETT by Wm TRYON, Esq., and Governor of North Carolina.

Excerpts from a letter written November 28, 1955 by Neil C Blanton of Rochester, Pennsylvania.

"All of the family records, in my family at least, were destroyed when what had been the old plantation home burned in my grandfather's time. It is quite probable that we are at least distantly related since all of us, according to the North Carolina clan at least, come from one Blanton.

"The first Blanton that came to this part of the country was named GEORGE BLANTON. About 1765 he came from Dinwiddie County, Virginia, migrating to a spot in what is now Cleveland County, North Carolina, about five or six miles West of Shelby on the West side of Sandy Run Creek. He was married to Elvira LEE in Virginia. They are buried at the old farm. This George Blanton was the first Justice of the Peace in Tryon County, appointed by King George III. on November 10, 1769, the year Tyron County was formed. Tryon County reached from the Virginia line and ran southwest to about where Charlotte is now located. All of North Carolina from Charlotte to the West was considered to be Tryon County.

"There is a written record to support the information thus far, but from here on most of it is word of mouth and you can find some conflict in most of the stories about the family.

"The first George Blanton had at least two sons. There were probably several other children as the Blantons have been very prolific. My own line comes from the branch with a second George in it. My great grandfather's name was <u>Jackson</u>. He had at least two brothers, JAMES and JOHN WESLEY. There seems to have been some confusion as to whether there was an added John, as Wesley was always called "Wesley". My grandfather's name was JOSHUA MONROE BLANTON. My father's name is HUDSON.

"The children of Burwell Blanton have better records since their Bible, etc. were never destroyed. Burwell had nine children that we know of and his eldest son, Charles Blanton was the first Sheriff of Cleveland County, North Carolina, which was formed in 1841. At the time of the formation of the County, an R. H. BLANTON was one of the first County Commissioners and it is said that he was another brother of my great grandfather Jackson.

"Such is the confusion of the history of the Blantons in the Shelby area. There are literally hundreds and hundreds of them. They take up several pages in the Shelby telephone directory, and there are still more of them in adjoining Rutherford County, and across the South Carolina line 18 miles away. If you will give me the name of your lineage as far back as you can trace them, I am pretty sure that they will eventually come to the Shelby Area in North Carolina, unless there was some branch that we don't know about.

"There is a version which says that the original GEORGE had a son named JOHN. George's son Burwell was married a second time when he was 74 years old and had grandchildren from that marriage before he died."

The Last Will and Testament of JAMES BLANTON of the Parish of St. James, Goose Creek, Charleston District, State of South Carolina, is recorded in Will Book K 1845-1851, on Page 486, dated the 15th day of November 1848, probated 4 June 1851.

lst: "I direct that my body after my decease, be decently buried and that my funeral be conducted without ostentation and in accordance with the discipline and usage of the Methodist E. Church.

2nd: "I direct that all my just debts be paid by my Executrix or Executor as soon after my decease as possible, out of the first money that shall come into their hands from any portion of my estate real or personal.

3rd: "Whereas I have heretofore made a division and given off legacies to my eldest set of children (by a former marriage) viz:

My daughter Harriet and her husband David SNELL.

My daughter Polly and her husband Malachia GROOMS.

My daughter Lovey and her husband William SALISBURY.

My daughter Caty and her husband Samuel M WAY, and

My son Thomas BLANTON.

I do now hereby give and bequeath unto each of them the sum of twanty-vive cents to be paid to each of them as their full and entire interest or claim of in or to any portion of my present estate real or personal....."

4th: "All the rest and residue of my estate real and personal I give and bequeath to my present beloved wife Mary E BLANTON and the children of her body by me, to her and their use and behoof (in common) for and during the term of the natural life of my said wife to be managed and controlled by her the said Mary E Blanton, but shall not be subject to any claim or interference of any future husband with whom she the said Mary E Blanton may hereafter intermarry.

"And after the decease of my said wife the said estate shall be equally divided, share and share alike, among as many of her children by me as may survive her or leave issue surviving her.

Eastly: "I do hereby constitute and ordain my beloved wife Mary E Blanton Executrix, and my esteemed friend Samuel P MILLER, Executor of this my Last Will and Testament ....."

Personally appeared in open Court Mary E Blanton and Saundra M Norwood, witnesses of lawful age and after being duly sworn, declare that on Saturday Morning about 3 Oclock June the 9th 1849, they were at the house of Giles McBride in said County, sitting up with One Dennis Carroll who was very sick of Dropsy and in addition thereto had had a chill on Friday Evening the 8th June-

They further State that said Carroll about 3 Oclock on the morning aforesaid Called them together with one Joshia Mason to bear witness to what he should say. He then Called Mary Ann McBride wife of said Giles McBride to his bed side and remarked that he was dying. but that he was as well in his senses as any of them, that he did not think he would live to see the sun rise, and handed Mrs McBride his gold watch and told her it was hers, that he gave it to her, for her kindness to him since he had been at her house sick. He then remarked, addressing himself to said affiants and said Mason, and calling on them to take notice of what he said that he wanted all his just debts paid and after they were paid he wanted his friend Giles McBride to have all his property -- He said he did not owe any thing of Account that he knew of He further said that if Mr McBride had been at home, he imould have had his will written out, but he said that what had been said to affiants and said Mason, would do as well as if he had written it on ninety nine sheets of paper. He also said that he wished said McBride to wind up his business for him - said affiants further states that said McBride was from home and that there was no person present that could write a Will and that said Carroll was in great agony and scarcely able to turn himself in his bed and totally unable to write. That said Carroll continued to grow weaker but retained his right mind till Monday the 11th June when he became senseless and remained so till he died at said McBride's house on Thursday the 14th day of June 1849

Excerpts from HISTORY of JOHNSON & HILL COUNTIES, TEXAS "Lone Star State" Page 612:

J H BLANTON, one of the prosperous farmers and stock raisers of Johnson County, was born in Howard County, Missouri, December 22, 1825, a son of JOHN and Mary J (BURGERS) BLANTON. The father was a native of Shelby County, Kentucky, and the mother of Rockingham County, Virginia. The father came to Missouri in 1824 bringing with him his mother-in-law, Mrs. Fristoe who had in charge the children of her husband by a former marriage. ... Mrs. Fristoe, their step-mother hired her son-in-law, John Blanton to bring the children to their relatives in Missouri. Mr. Blanton remained there only a few years when he moved to St. Francois County, Mo., and several years later to Scott County, next to Kentucky, and in 1856 to Texas, locating in the southern portion of Ellis County. He died in that county in March 1867 at the age of 67 years.

Mr and Mrs Blanton had ten children, viz: J. H., our subject; Casandrie; Mildred; William; Harriett who was the wife of L C THOMPSON; Margaret; Edman of Terrell County; Martha; Lucy, wife of Andrew LLOYD; and Bolin of Cooke County, Texas. Mrs. Blanton died on August 10, 1859.

The subject of this sketch was educated in the common schools of Kentucky and at the age of 21 he engaged in farming. He afterwards took up the study of Dentistry and was engaged in active practice from 1852 until the breaking out of the late war. Mr. Blanton came to this state with his father in 1856, passing a portion of his time at Waxahachie, but his headquarters were in McKinney, Collin County, Texas. The doctor practiced his profession over the greater portion of 5 or 6 counties and during this time he was frequently in the West but was never troubled by the Indians. At the commencement of the late war, he joined Company F., Capt. J C Brown's Twelfth Cavalry Regiment, Commanded by Colonel PARSONS. Dr Blanton was in the battle of Cotton Plant and remained only one year with Parson's command. Twelve months later, he joined Col. FORD'S command, on the Rio Grande, and during his term of service was in a number of skirmishes, the most noted being the little battle fought after Peace was declared on the Rio Grande River.

The Confederates secured possession of the battle field, several prisoners, horses, arms. ammunition. etc.

After the close of the war, Doctor Blanton returned home and engaged in farming, locating in what was then Ellis County, now Johnson, on the farm where he now resides. He has since added to his first portion of 80 acres until he now owns 400 acres, 100 acres of which is cultivated. He also owns another farm of 315 acres with 147½ acres under cultivation, 327 acres of timber and prairie land, and is successfully engaged in stock raising. Mr Blanton was married December 10, 1874 to Miss M E CHRISTIAN of Bell County, Texas, and a daughter of Hiram and Sarah (BURKS) CHRISTIAN natives of Tennessee. The parents came to Bell County, Texas in 1853 where they reared a family of 12 children.

Mr Blanton is a member of the AF & AM Waxahachie Lodge. Mrs Blanton is a member of the Christian Church.

Mrs Mary B MAULDIN of Fort Worth, Texas -a descendant of JEREMIAH BLANTON (1774 Va-1872 NC) is of the opinion that her ancestor JEREMIAH BLANTON had a brother named JOHN Blanton born Virginia. It is entirely possible that this tradition is a fact, yet thus far there is no proof to substantiate the tradition. WILLIAM Blanton born prior to 1740, conveyed land in 1782 Brunswick County, Virginia, is known to have had four sons: Clayborn; Obediah; Jeremiah born 1774; and William Blanton II. all at one time were residents of Rutherford County, North Carolina. In all probability there was also a son named JOHN, as there appears to have been a "John" and a "William" in every early Blanton Family.

Another unconfirmed belief is that of Mr Chris MORGAN of Memphis, Tenn. Mr. Morgan is of the opinion that the WILLIAM Blanton of Tallahatohie and Yalabusha Counties, Mississippi, whose wife was Eliza DUKE, and son Charles D Blanton -WILLIAM died 1842, his will is in Yalobusha County-"came with the mass migration to the area from Maury County, Tennessee."

## Lyndon Baines Johnson

It was daybreak, Thursday, August 27, 1908, on the Sam Johnson farm on the Pedernales River near Stonewall, Gillespie County. In the rambling old farmhouse of the young Sam Johnsons, lamps had burned all night. Now the light came in from the east, bringing a deep stillness, a stillness so profound and so pervasive that it seemed as if the earth itself were listening. And then there came a sharp compelling cry -the most awesome, happiest sound known to human ears-the cry of a newborn baby; the first child of Sam Ealy and Rebekah Johnson was "discovering America".

He was a large, well-formed child weighing about ten pounds, the attending physician, Dr. John Blanton of Buda, estimated. His grandmother Baines was first to take him in her arms, calling him a wonderful boy, with which Aunt Kate Keele agreed, adding that she could see the

Bunton favor.

The proud father-never was there a prouder-assured that all was well with his wife and son, dashed out of the house to saddle Fritz, his splendid grey horse, and gallop up the road to break the glad news, "It's a boy," to his parents in the next farmhouse and other kin farther up the road.

The birth of their son brought great happiness and great changes in the lives of the Sam Johnsons. The father had ardently desired a son and each day his plans and hopes for the boy grew. The mother looked into her son's brown eyes seeing in them not only the quick intelligence and fearless spirit that animated her husband's flashing eyes, but also

In the Daughters of The Republic of Texas (DRT) Library at San Antonio, Texas, the mother of Jean W WILSON of Liberty, Texas, located a copy of A FAMILY ALBUM by Rebekah Baines JOHNSON, the mother of LYNDON B. JOHNSON.

Page 17 tells of the birth, on August 27, 1908 of LYNDON BAINES JOHNSON and says "he was a large, well-formed child weighing about ten pounds, the attending physician <u>Dr. John Blanton</u> of Buda, estimated."

This record verifies the tradition that "Dr John J Blanton who practiced medicine in Texas, around the turn of the century, delivered President Lyndon B JOHNSON, having ridden nine miles on horseback to do so."

Capt. B. B. PADDOCK'S History of North and West Texas, published 1906 by The Lewis Publishing Company, pages 550, 551 has a sketch on this family of Blantons.

Dr. John J. (the youngest son of Dr John B Blanton born 1839; died 1879 Clay County, Texas) was born in Wise County, Texas in 1876 and graduated from the University of Nashville, <u>Tennessee</u> in 1900. His children were:

i. William Preston Blanton born 20 Jun 1902. Physician; died Alaska. ii. Joseph Arnold Blanton of Los Angeles, California iii. Neal Elliot Blanton died in Alaska in his early 20's.

Dr John B Blanton, father of Dr John J Blanton, was son of Dr Jacob Blanton, a Virginian and a Cumberland Presbyterian Minister. Dr. Jacob Blanton was born in 1808.

The 1880 US Census Wise County, Texas enumerates:

BLANTON, John Age 35 Birthplace: Kentucky 30 "

Della -dau- age 10; Willie -son- 8; Emma -dau- 4; John -son- 3. All children born in Texas.

This is the John Blanton whose wife was Mattie J CLARK. Della married Dr. William P Blanton; Emma married E A WELLS. Dr. John J Blanton, born 1876, shown as age 3 years in 1880, is the Dr John J Blanton who attended the birth of President Lyndon B JOHNSON, in 1908.

Paddock's History states that JACOB BLANTON (ancestor of Dr John J) was from Murray County, Kentudky. There appears never to have been a County in Kentucky known as "Murray". In Calloway County, Kentucky, there is a town named Murray. The 1850 Census of Calloway County, Kentucky lists no Blanton family. However, there are a great number of BRANDON family entries.

1830 US Census Bedford County, Tennessee enumerates two men named <u>JACOB</u> Blanton, one of whom lived in dwelling adjacent to MEREDITH Blanton, who was a son of JOHN BLANTON whose estate is in 1807 Cumberland County, VA.

colleges of the craft and pursued his profession with much success. He moved into Kentucky when it was new and before the rebellion settled in Arkansas. For his wife he chose Sarah Donnell, who bore him three children, namely: Mary. the wife of John D. Smyth, of Parker county, Texas; James W., who died at Chico, and the

subject of this sketch.

John B. Blanton acquired a liberal scholastic education, and the foundation for a professional career was well laid before he began his preparation regularly for the work. He took lectures in the Virginia College of Medicine at Richmond and graduated in 1860. He had hardly begun his career when the war came on and he was made a surgeon in the Confederate service. General Cabell, of Dallas, was his commanding officer and he was also attached to the army of General Lee. After the war he located at Clifton, Texas, and, in 1874, he came to Wise county and established himself at Aurora. After practising there a few years he removed to Decatur, and in 1880, came to Chico, where his death occurred April 25, 1904. In 1869 the Doctor took a course of lectures at Jefferson Medical College, at Philadelphia, taking a diploma from the institution. He served many years as a member of the Board of Medical Examiners for Wise county, and was recognized everywhere as authority on matters pertaining to his profession. He took no leading interest in politics, as doctors sometimes do, but held to the principles of Democracy with an abiding faith. The emoluments from his practice were considerable and he amassed property in real estate to provide comfortably for his family when he should be taken away. He encouraged his two sons to take up medicine as their life work and saw them strongly equipped and engaged in successful practice before his death.

Dr. Blanton first married Miss Frusie Peek, at Clarksville, Texas, but she passed away without issue. In 1867 he married Mattie J. Clark in Coryell county. She was a daugher of William D. Clark who settled there in 1855 from Bedford county, Tennessee, and died in 1893. Mr. Clark married Eliza R. Kelton, who passed away in 1896, the mother of James L., of Hico. Texas; Mrs. Dr. Blanton; Thomas, deceased; William, of Marlin, Texas; Anna, wife of William Kincaid, of Buffalo Gap, Texas; Newton, of Waco; Samuel, of Hico, and Finis, of Merkel, Texas. Four children were born to Dr. and Mrs. Blanton, viz.: Della, widow of Walter Tadlock, of Chico; Dr. William P., of Crafton, a graduate of the Louisville Medical College, and

married to Piety Borden, with children, J. Burgess, B. F. and Pancoast; Emma, who married E. A. Wells, of Wellington, Collingsworth county, Texas, and has issue, Ruth, Blanton, Morris and Eddie; Dr. John J., the youngest, was born in Wise county, Texas, in 1876, and graduated from the University of Nashville, Tennessee, in 1900. He succeeded to the practice of his able and worthy father and is already referred to as a foremost practitioner of Chico. He married Miss Cue McCurdy in 1901.

JOHN B. BLANTON, M. D. For forty years the late Dr. Blanton, of Chico, maintained the dignity and honor of the medical profession. For more than thirty years he practiced among the people of Wise county, where he laid down his life, and both as a physician and a citizen he won the friendship and merited the praise of a wide constituency and acquitted himself as becomes a gentleman and a man. Coming from a family of doctors, as he did, he was peculiarly and especially fitted and equipped by nature to battle with disease and to encourage the afflicted, and when he was taken away his roof alone did not cover the house of mourning.

Murray county, Kentucky, gave Dr. Blanton birth February 24, 1839. Dr. Jacob Manton, his father, was a Virginia man and a Cumberland Presbyterian minister, taking up active church work when he abandoned medicine and closing his life in Clay county, Texas, in the ministry in 1870. He was born in 1808 and studied medicine thoroughly, graduating from two
