I Nathaniel Chatterton aged
seventy two years do upon oath testify and declare
that about or in the year one thousand seven hundred
and eighty two I enlisted or entered the service as a private
for the term of "during the war" in the regiment, commanded
by Bob Lamb and served in said regiment until the close
of the war when I was regularly discharged from the
said Regiment.

I further declare, that I have never received a warrant
for the bounty lands promised to me on the part of
the United States, nor have I ever signed or transferred
my claim in any manner whatsoever.

I therefore know all
men by these presents that I Nathaniel Chatterton
do hereby constitute and appoint
Orlando Baynton of Rivers Point in the County
of Clinton to be my true and lawful attorney,
for me and in my name to demand and receive from

The Secretary of War of the United States a warrant
for the quantity of land due to one as ofors and
and my said attorney is hereby fully authorized
and empowered to constitute and appoint one
or more substitutes or attorneys under him for
the special purposes above expressed

In witness whereof I have hereunto affix
my hand and seal this ninth day
of September 1823 of September A D 1823.

I Joshua Adels aged twenty years do solemnly
declare that I have been long acquainted with Nathaniel
Chatterton who has subscribed the above declaration
in my presence, and well knows that he is the identical person
he therein represents himself to be and I further know or do
believe that he did perform the military services therein
stated

For the purpose of obtaining the benefits of an act entitled "An act for the Relief of Certain Surviving Officers and Soldiers of the Army of the Revolution" Approved on the 15th of May 1828 I Nathaniel Chatterton of the County of Westchester in the State of New York do hereby declare, that I enlisted in the Continental Line of the Army of the Revolution for & during the war & continued in its service until its termination; at which period I was a private in Captain Thomas' Company in Col. Lamb's Artillery Regiment of the New York Line - And I also declare, that I afterwards received Certificates for the reward of Eighty dollars, to which I was entitled under a resolve of Congress, passed the 15th of May 1778 - And I further declare that I was not on the fifteenth day of May 1828 on the Pension List of the United States - Witness my hand this ninth day of July in the year of our Lord one thousand eight hundred and twenty eight -

Declaration

In order to obtain the benefits of the act of Congress of the 7th of July 1838. Entitled an act granting half pay & pensions to certain Widows State of Vermont
Grand Isle District Be it remembered that on this 13th day of September A.D. 1863 personally appeared before the Court of Probate in and for the District of Grand Isle ap^o: Mary Chatterton (alias Chatterton) a resident of the town of Lacole in the Province of Canada, aged Sixty two years, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefits of the provision made by the act of Congress passed July 7th 1838 granting Pensions to Widows of persons who served during the revolutionary War, that she is the widow of Nathaniel Chatterton (alias Chatterton) who was a Soldier or a Matrop in Col. Lamb's 2^d. Artillery New York Line, and served during the most if not all of the revolutionary war, for which service he obtained a pension under the act of fifteenth of May one thousand eight hundred and twenty eight, was placed on the Pension List on the 5th day of December 1828 his pay which was one hundred

dollars per annum, commencing upon the 1st day of March 1826. That when he obtained his pension he was a resident of Champlain in the County of Clinton State of New York. She further declares that she was married to the said Nathaniel Chatterton in the month of October 1783 the fall after the close of the revolutionary war, by the Rev^d. Wheeler Case a Clergyman of the Presbyterian order, who was settled in Phasant Valley a town in Dutchess County State of New York, & resided in a town called Clinton adjoining Phasant Valley. That her husband the ap^o: Nathaniel Chatterton died the 2^d day of August 1835 that she was not

Pheasant Valley, that her husband the apt. Nathaniel Chatterton
died on the 2^d day of August 1825, that she was not
married to him prior to his leaving the service, but the
marriage took place previous to the first day of
January 1794 (Viz) at the time above stated. She further
declares that when she married the said Nathaniel Chatterton
she was a widow, her first husband, Robert Storm, died
about six years previous to her marriage with the said Nathaniel
Chatterton, that her maiden name was Mary Manning, &
that she is now the widow of the apt. Nathaniel Chatterton
who was a United States pensioner when he died. She
further saith that she has no record of her marriage
nor never had any in person of ^{her} Mary Chatterton
