Nos. 51-62; Bruere (1 doc.), Hulse (3 docs.), William Brewer (remainder)

51. Monmouth County Orphans Court, Book D, pages 339-343, 19 October 1813. Peter Bruere, Price Bruere and James Bruere, executors of James Bruere, deceased. Division of real estate.
52. Monmouth County Deed Book H, pages 175-177. Indenture dated 10 July 1733 (1735?). Recorded 26 March 1737. Hannah Holsart and John Holsart, executors of the last will and testament of Benjamin Holsart, deceased, of the one part and Thomas Werne of Amboy in the County of Middlesex of the second part. Hannah Holsart and John Holsart convey land situate in Monmouth County to Thomas Werne.
53. Monmouth County Orphans Court, Book C, pages 3-4. April 1801. Magdalene Huls, administrator of the estate of Ezekiel Huls. On application for the sale of real estate.
54. Monmouth County Orphans Court, Book D, page 300-301. Special Orphans Court, 20 March 1813. Thomas Hulse, son of Silvanus Hulse, deceased (a minor over the age of 14 years). Joel Hulse appointed guardian until said Thomas Hulse attains the age of 21 years. Bound of \$500, Richard Freeman and Isaac Brewer, sureties.
55. Monmouth County Deeds, Book G, page 43. Indenture dated 18 Feb 1721, Charles Mott of Hempstead in Queens County on the Island of Nassau of the one part and Samuel Hoffmire, Benjamin Hoffmire and William Hoffmire of the Township of Middletown in the County of Monmouth in the Eastern Division of New Jersey, of the second part. For three hundred pounds, Charles Mott conveys to Samuel Hoffmire, Benjamin Hoffmire and William Hoffmire, land situate in the township of Middletown, containing by estimation 150 acres, joyning to land late of Henry Tilton and Samuel Tilton and now in the possession of William Brewer, made over unto said Charles Mott by Samuel Hoffmire, deceased, father of the said Samuel Hoffmire, Benjamin Hoffmire and William Hoffmire, by mortgage bearing the date 20 May 1708.
56. Monmouth County Deeds, Book G, pages 149-150. Indenture dated 18 Feb 1725. William Brewer of Middletown in the County of Monmouth and Eastern Division of the Province of New Jersey, yeoman, of the one part and William Leeds of Middletown aforesaid, of the second part. For the sum of eighteen pounds, William Brewer conveys to William Leeds that piece of salt meadow situate lying and being in the cove of meadow that is most northerly from the meadow of Thomas Shepard and William Lawrence. William Brewer signs by his mark. Witness: John Johnston, Junior.
57. Monmouth County Deeds, Book H, pages 84-85. Indenture dated 13 May 1726. William Brewer of Middletown in the County of Monmouth and Eastern Division of New Jersey, yeoman, and Mary, his wife, of the one part, and Samuel Hoffmire, Benjamin Hoffmire and William Hoffmire of the town and county aforesaid of the second part. William Brewer, for two hundred and

thirty six pounds, conveys to Samuel Hoffmire, Benjamin Hoffmire and William Hoffmire, a tract of land situate and lying in Middletown. Signed by William Brewer with his mark.

58. Monmouth County Court of Common Pleas at Freehold. Whereas William Brewer, late of the county of Monmouth, yeoman, attached to appear...10 April 1735, to answer to Jacob Janeway and John Broughton Mercts (Merchants) in a case of debt for seventeen pounds.
59. Monmouth Co. Court of Common Pleas, October term 1735. William Brewer, late of Monmouth County, yeoman, to answer Jacob Janeway and John Broughton, Mercts of a plea of trespass
60. Monmouth Co. Court of Common Pleas, January term, 1735. William Brewer, late of Monmouth County, yeoman, to answer Aaron Longada(?) Merct of a plea of trespass on 4 November 1734.
61. Monmouth County Court for holding of pleas. Casparus Vanostrandt complaint against William Brower otherwise called William Brewer of Readington in the County of Hunterdon, yeoman in custody of Bernardus Verbryck, Esq., High Sheriff of the said county of Monmouth, regarding a debt of fifty pounds eight shillings for what whereas the said William the 15th day of December 1733 at Freehold in Monmouth County within the jurisdiction of this court, acknowledged he was bound to said Casparus for fifty pounds to be paid to the said Casparus... (This followed by a document): "That I William Brewer of Readington in the County of Hunterdon, yeoman, am firmly bound unto Casparus Vanorstandt, blacksmith, in the County of Somerset in the sum of fifty pounds and eight shillings...signed and sealed 15 December 1733 by William Brower (his signature). NOTE: In the deeds above (Nos. 55 & 56) William Brewer signs by his mark. In this bond, William Brewer/Brower signs his name. These are two different men named William Brewer.
62. Monmouth County Court for the holding of pleas, October term 1735(?). Casparus Vanostrandt complains against William Brower in custody of Bernardus Verbryck, Esq., High Sheriff of Monmouth County, whereas William the first day of July 1735 at Freehold in Monmouth County within the jurisdiction of this court was in debt unto said Casparus in twenty eight pounds, for smith work by him the said Casparus.
