GOAL:

John Tarwaters complete identity.

OBJECTIVE:

Locate the survey associated with 1827 Warren County entry no. 2469 and John Tarwater's 1832 Grant No 2740. Note whose name on the survey.

BACKGROUND:

In 1836 Coffee county was formed from Franklin, Bedford and Warren counties. There were no Tarwaters in Warren county the year Coffee was split off¹--yet in 1827 an entry (No. 2469) for 125 acres was made in Warren county that in 1832 became grant No 2740 that was issued to John Tarwater Sr.² So between 1832 and 1837 something happened to the land. It might have changed county jurisdictions, but even so, in Coffee county John Tarwater is not being taxed for all 125 acres --just half; and it has been a puzzle to me as to why the grant referred to him as John Tarwater Sr when, at this time, I have no evidence of another John Tarwater being in Warren or Coffee counties. It is entirely possible that a male Tarwater who had an entry and/or survey died intestate, and so John Tarwater Sr finished the process as a guardian for a heir(s). If so the name on the survey and entry may not be John Tarwater.

This line of thinking is supported by the enumeration of one Rachel Tarwater as head of household in the 1830 U.S. Census for Warren County, Tennessee³--especially when John Tarwater was NOT in

Warren County for the 1830 U.S. Census, but rather he was in Franklin County, Tennessee.⁴

A note about Rachel, she was age 30-40, but probably closer to 40 as she had 2 "children" ag 15-20. Men close by old enough to be Rachel's father were Thomas Boren ag 50-60 and John Copeland ag 50-60. Immediate neighbors were Abner C Womack and Thomas Boren. None of these fellows were mentioned as bordering property owners in John Tarwater's grant. Abner C Womack is found in the 1840 U.S. Census in Warren County.⁵ Dower law in Tennessee in 1837 gave the widow rights to 1/3 of an intestate's land.⁶

John Tarwater's grant does mention a John and James Mullican, Drury Wamacksten, Thomas Warmack and John Martin. The Warmarck/Womack connection really begs the support of the acquisition of the the survey. Thomas Wamack is found in Warren County in the 1840 U.S. Census⁷

The last piece of background information - supposedly a Nancy Ann Tarwater married a John Mullican.8

RESEARCH SUMMARY: (Actual notes in Appendix: Extraction Notes)

The survey was located and it did turn out to be in John Tarwaters' name.

The survey date of the 18 of December 1830 is interesting. December is not the first month one would choose to do a perform a survey (although it is after the first frost, which would kill off some shrubbery). The survey may be happening in December because an estate is trying to be processed--or just because it's the last decent month before all the snow sets in.

Thomas WOMACK and Thomas BOREN were the sworn chain carriers (SCC). Usually the SCC are family members, bordering neighbors or very close and trusted friends. This places Thomas Boren as the more likely candidate for Rachel's father.

In the only other survey to mention a Tarwater, we learn that Thomas Boran's property is touching "a 125 acres survey made for John Tarwater".

An effort was made to grab all the Little Barren Creek surveys and key FAN club names: Mullican, Womack, etc during the notes extraction process. This paid off in the discover that John Martin's 1829 survey mentions both Drury Womack and the **mouth** of Barren Creek. Since Drury was a bordering land owner to John Tarwater, it may well be that a Little Barren Creek takes off Barren Creek near the mouth of Barren Creek. If this is so, then it is significant that Barren Creek criss-crosses the DeKalb/Warrren border near its mouth. However it is also possible that Drury had several tracts of land.

It has been difficult to place Little Barren Creek on the map. A search on USGS.gov lists 2 Little Barren Creeks - one in the Smithville Quadrangle above the Smithville-Sparta Hwy in DeKalb County, Tennessee and one in the McMinnville Quadrangle. I could not locate a Little Barren Creek on the Smithville Quadrangle - nor was Cany Fork on the map. The one in McMinnville Quadrangle turned out to be Barron Fork with no branch labeled as Little Barren Creek - nor is

Cany Fork on the map. I believe Little Barren Creek to be an off shoot of Barren Creek whose mouth empties into Cany Fork River.

Note that the last survey I deemed worth extracting from vol 3 (vol 3 went to 1839) was for 1837 -- which is the same year DeKalb County was formed. It is pretty difficult to rule out "**Little** Barren Creek" being in DeKalb from our USGS map. [see map in Appendix: Maps]

RECOMMENDATIONS:

- 1) Obtain the entry that this survey was made from.
- 2) We have an abstract of the survey provided by the high quality researcher Nora Williams; but we still should get the actual image.
- 3) Search the Warren County, Tennessee Deed Index. Effort should be made to find an "every name" deed abstract work if available, rather than relying on the original deed book indexes. Locating any additional land Rachel's husband may have had in Warren County must be done before one can assess how much land she would have retained for her dower.
- 4) Search the DeKalb County, Tennessee Deed Index. Effort should be made to find an "every name" deed abstract work if available, rather than relying on the original deed book indexes.
- 5) Search DeKalb County, Tennessee Probate Records where John Tarwater may be found involved in some estate records of the Tarwater man who was married to Rachel.
- 6) Do an online preliminary surveys on the Thomas Womock, Thomas Boren and John Mullican families.




