Frederick, of Johnston, referred to as IA herein 5 referred to as "Jan"; Mark L. Frederick, of Flaxville, MT herein referred to as "Mark"; Claude Frederick, of Flaxville, 'MT herein referred to as "Claude"; and Mark and Claude as co-personal repre-6 sentatives of the estate of Percy G. Frederick. 7 THE PARTIES AGREE AS FOLLOWS: 8

Percy G. Frederick, same person as Percy Frederick, herein
