DB 2 P 550 - 8 March 1747 - Levi Leigh sold 100 acres to James Campen land on Leigh Creek in Pamptico River ... beginning at a marked tree at a little point above the horse pasture and from thence near a Tar Kiln to another bounded tree from thence toward the head of the creek to a gum marked with two notches, and from thence to the head line a direct course, likewise up the creek; which parcel of land was conveyed Levi Leigh to one of my heirs.

DB 2 P 512-513 - 14 Sept. 1747 - Levi Leigh of the county of Bath and province of North Carolina planter, sold Abraham Pritchett of same place, 600 acres ... being on the south side of Pamptico River, beginning at the point of the James Leigh Creek, running up the said creek to a marked tree at a little point above the horse pasture to James Leigh's line, and along the said Leigh's line to the back, and along the back line to the head of a gut called the second gut, and down the said Gut to Pamptico river and up Pamptico River to the first station, and all houses, buildings, gardens, orchards, lands, woods, ways, waters casements and advantages of the said land...

DB 4 P 298 - 6 Sept. 1770 - Leven Leigh of the county of Beaufort, N.C. planter, sold 100 acres to Richard Harvey ... on the W. side of Durham's Creek on Juniper Swamp beginning at a pine by George's pend and a branch ? running S. 50 E. 127 poles thence ? S. 39 W. 127 poles then N. 57 W. 127 poles to the beginning. Witnesses: Joshua Roe, James Roe, and Richard Roe Proved in October infer. Court by oath of Joshua Roe.

DB 9 P 141 - 18 Aug. 1812 - Levy Lee and Milley Lee (his wife) sold 50 acres to Capt. David Lewis of Gates Co. N.C. ... one certain ? of the tract of land we now live Beginning at a Pine Stump in the Reedy branch or Marsh Taylor Cross's Corner thence with his line South or there about 127 poles to a Pine A Corner thence South 65 E. 72 poles to a Pine thence N 4 W 150 poles to the Center of the Marsh John Gatlings line thence with his line to the beginning.

No date - The Grand Jury presents to the Cort Levi Lee son of Levi Lee dec. wishes him to be bound to Ja. Custis ? or Jas. Carter ?

15 Nov. 1819 - Stephen Lee administrator of the estate of Levi Lee deceased owes the court 4 dollars and fifty cents (\$4.50) (Court of Gates County, N.C.) for the cost and charges of a suit brought by Levi against the administrator of Edward Vann deceased.

Pitt Co.

18 Nov. 1828 - Levi Lee of the county of Pitt and state of N.C. for \$200 sells a Negro slave about 12 yrs. old named Boll to Nathan Brown.

DB MM P 236 - 1 August 1849 - Levi Lee of the State of North Carolina for the purpose of paying his debts sells his life estate in the land on which I now live to Jesse Stancil ... land in the county of Pitt and on Great Center Creek, adjoining the lands of William T. Elinor and Frederick Hopkins containing 54 acres (the divided lands of the late Amelia Hopkins and drawn by his daughter Polly deceased wife of the said Levi Lee.

- Craven County 1790 No census records for Levin Lee who married Keziah in Craven or Beaufort Counties yet he was old enough to be on his own. Where was he?
  - 1800 Levin Lee 3 males under 10, 1 male 26-45, 1 female, no slaves
  - 1830 Levin Lee 2 males under 5 , 1 male 15-20, 1 male 70-80, 1 female under 5, 1 female 5-10, 1 female 10-15, 1 female 30-40, no slaves
  - 1850 not on this census
