

"Old" John Godbold in South Carolina Documented Facts

Sep 3 1725	An able bodied seaman named John Godball joined HMS Scarborough when the ship was stationed in Charleston, South Carolina. He "ran" from the ship October 31st of that same year with Frederick Richardson.	ADM 36 3390 Public Public Record Office (PRO) Kew London England
May 10 1729	John Godbold witnessed a deed of sale in Craven County. Land was described as:"Bounding N on Ichaw Creek, W on Abraham Nichaw, S on vacant land, E on Christopher May.
