Parish Registers were started in England in 1538. A law had been passed ordering the clergy to record baptisms, marriages and burials and early records were kept on parchment or paper. No records were kept before this date except a few monks recorded the events of prominent families. It was not however until 1598 that the records were required to be kept in books, and parishes were instructed to backdate them to 1538. Few did so, and few parishes have records that survive from 1538. A few of the earlier paper/parchment survivals are classed as BT's in the catalogue.

Bishops Transcripts By 1598 it had become the recognized practice for the incumbent to send to the Bishop a copy of the years' entries in the parish registers. These copies are known as Bishops Transcripts or BTs. Where they have survived they are useful, not only when the original registers have been lost, but even when they have survived, as the Bishops' Transcripts may provide different or additional information. As they are contemporary with the parish registers they present the same handwriting problems.

Look for a source for the information, such as 1900 census, pg. number, line number and other information. More than likely just showing the 1900 means it has been copied by someone else before. Always check to see if the sources are there. Ancestry does have a lot of good points too. They have several records on line which you need to purchase a subscription to. They have census records, marriage, death records, books, newspapers and etc.

Also, on the Internet, did you know many of the states have records online? Check those states out and see if any of your family are there.

Hawkins Family Group-04 (My, your editor's, family group, phil_hawkins@sbcglobal.net): Earliest known common ancestors are Jeffery and Dorothy (Mattock) Hawkins, emigrating from Wilts, England in 1682 to Bucks Co., PA.

You do not have to be a participant to send material for this family group. Old pictures, family stories, unanswered questions, brick walls, whatever would be of interest to our line, to your branch of the line, or information on a particular event that might have been an influencing factor in the history of an ancestor (s). If you send pictures please scan at 300 dpi, and furnish the who/when/where/why to the extent you can.

Last month I listed the information that I had on Geoffrey Hawkins, buried Bishopstrow 1603/04. It is thought that he might be our Jeffery's grandfather, but nothing has been found to support that thought.

I am working at this problem by building a database on all the Hawkins in Wilts in the 16th & 17th centuries hoping that some kind of pattern for possible Hawkins lines can be developed. As a part of this I have started another project, see HAWKINS SURNAME - WILTSHIRE, ENGLAND at the front of this letter, to identify as many Hawkins in Wilts in the 1500s through the 1900s as possible.

During the past month I have identified our Joan Hampton Hawkins's second husband, following Geoffrey's death.

"Assignment of lease of land in Bishopstrow. Robert Hippiisley and Joan his wife (late wife of Jeffrey Hawkins) to John Temple."

And from *Some Notes on the Hippiisley Family*, A. E. Hippiisley & I. FitzRoy Jones (Eds), Wessex Press 1952, page 25:Robert, bapt. 1583 Aug 11. In 1611 in a bond from his sister Dorothy he is described as 'of Bishopstrow, Wilts.' He married Joan dau. of John Hampton, of Urchfont, Wilts, a sister of his brother Ferdinand's wife. They had issue: Joane, who married [] Hawkins, and Dorothy. [Robert was a son of John Hippiisley, of Ston Easton, & Dorothy Horner. His siblings were John, Ferdinando Thomas, Anthony, Morice, +]

Page 77:Ferdinando Hippiisley, 2nd son was born between 1577 and 1579..... He seems to have been of a wild and roving disposition. Page 78: He married 1604 Oct 21 Elizabeth, dau of John Hampton, of Urchfont, Wilts, a sister of his brother Robert's wife. He had issue: John c1604, Ferdinando 1608, Charles, etc.

[All the data was indexed, but most of the reference numbers were not readable. Urchfont is northeast of Warminster, about half way to Swindon.]

Still no connection with my DNA cousins but I will try to give some insight as to why I believe the Benjamin Hawkins' in Amelia and Prince Edward Counties of VA fit my family tree.

The first Ben in Amelia died interstate on July 19, 1745 and a Benjamin Baldwin made oath that he died without a Will.

The second Ben sued for B. Baldwin who was the administrator of the estate of the first Ben. The second Ben died in 1771 in Amelia/Prince Edward Co. leaving his wife, Mary as the administrator of his estate.

Now to number three of the Benjamin Hawkins' of Amelia/Prince Edward Cos VA. This one died in 1777 leaving a will that apparently was made on his death bed. He named his wife, Amey as the administrator and also named his "son-in-law" Owen Smith to take care of the land for his sons, the Hawkins boys (not named). Two boys Robert and William were placed in the care of two different gentlemen leaving the impression that they were not of age but were to be apprentices of these men.

Robert Hawkins who later moved to Sumner Co. TN with his second wife and their family died in 1840. His will stated that he had given all he intended to give to his children by his first wife, Elizabeth. Before he moved he sold property to his brother Benjamin - yes a fourth one. In the deed transaction it was stated that the land had been left to Robert by his father Benjamin.

I found this information in Amelia Court Books, Deed Transaction and the VA Genealogist.
