"I've rescued' three old photographs belonging to the HAWKINS Family of Missouri. The first is a photograph of Reuben HAWKINS which was taken at the Dunlap Studio in Chillicothe, MO. The photograph appears to have been taken in the 1880's with Reuben appearing to be in his 40's or 50's at the time it was taken. In addition to his name, someone has written "Jennie's Uncle" on the back of the photograph."

"The second photograph is of Ethie HAWKINS and was taken at the same studio in Chillicothe, MO, likely at the same time in the 1880's with Ethie likely in her 30's or 40's at the time. In addition to her name, someone has written "Uncle Reuben's wife" on the back of the photograph."

"The third photograph is identified as including Jennie HAWKINS and was taken at the Genelli Studio in St. Louis, MO. There are three girls in the photograph with Jennie indicated as the girl on the left. This third photograph was likely taken in the 1890's with all three young ladies likely in their teens at the time."

Based on limited research I was able to gather the following information regarding the family:

Reuben HAWKINS b. 1834 in Franklin Co. IN to parents David HAWKINS (b. 17 May 1805) and Margaret J. ALLEY (b. 6 Jan 1811 in Russell Co, VA). Reuben was the oldest of the couple's 8 children including, Reuben; Jasper; Samuel; Nathan; John; Zerelda; William W.; and Elvira Ann HAWKINS all born between 1834 and 1851 in IN and MO.

Reuben HAWKINS married Nancy Ethaline HICKLIN (b. 25 Dec 1845 in Livingston Co. MO) on 1 Mar 1866.

Chillicothe, MO census records list their children as Lydia, Franklin, Adalaide, Reuben, and Margaret.

Hawkins Shoals, on the Tyger River in Union County SC from an altitude of 4671 ft. (from 42 miles in



space you can view all of Union County). This is copied using Google Earth, a free program that can be downloaded at www.google.com (Google Earth lets you fly anywhere on Earth to view satellite imagery, maps, terrain, [3D](#)

[buildings](#), from galaxies in outer space to the canyons of the ocean. You can explore rich geographical content, save your toured places, and share with others). I used the distancing feature to confirm that this location is on land owned by my James Hawkins (1715-1793) as shown in the Union County Land Grant maps. He had a saw and grist mill at this location and 100 acres stretching to the southwest (in the direction of the line crossing the river. The location is 34°31'12.50"N and 81°31'35.37"W at an elevation of 303ft. Driving directions from Carlisle (southeast corner of the county) are to take SC 72/121 southwest for 7.7 miles, turn left on Goldville Rd /St 44/292 for 1.3 miles, slight left for .4 miles, turn left for .3 miles, and stop. This James is the subject for Family Group-04 this month.

With several people considering the purchase of the 23andMe kit during the special promo period [just past], I've had lots of questions about DNA testing in general, about how autosomal testing works, and about possible uses for this test.

The most common question I've received about the new test is if it will detect Native ancestry.

Ironically, I've spent the past 10 years trying to get people to understand about paternal dna lines (yline testing) and maternal dna lines (mitochondrial dna testing). And everyone has done a great job of learning that, so now folks are having trouble shifting gears.

The answer is yes, it will help you determine if you have Native heritage AND IT HAS NOTHING TO DO WITH MALE OR FEMALE LINES OR IF MALES OR FEMALES TAKE THE TEST.

This test tests over half a million locations of your DNA. Compare that to the various yline tests which test 12, 25, 37, 67, etc or the mtdna test which tests between 1000 and 16,000 locations, depending on the test your order. This is a different kind of test entirely and does not replace those kinds of tests.

In this test, you will receive your percent of ethnicity divided between European, African and Asian. In our case in the US, Asian would equate to Native heritage. So if your Native ancestor is far back in your pedigree chart, you can expect to see a few percent of Asian heritage. This answers the question of "if", but not the answer of "who" the ancestor is who contributed that Native heritage. For that answer, you'll need to revert to the traditional yline and mtdna testing which, if you find enough people to test in your tree, will eventually show which of your ancestors was indeed the Native heritage contributor. Unfortunately for many of us, it will be one of those women whose first name we have and nothing more, or perhaps someone yet unidentified in our charts, making tracking people descended through a female only line impossible. For us, just knowing positively that we do, or don't, have Native heritage may be the best information we will ever be able to glean. On the other hand, if we do have Native heritage, we can use the Relative Finder feature to locate cousins and then we can ask them if they too have Native heritage, so we can probably eliminate some lines in that fashion. We can also arrange for others to test who are in our pedigree chart to see if they too have native heritage, although one has to be careful with drawing conclusions from others tests because Native heritage might have entered their lines from another source. The best bet would be to have our parents test so we can see where it came from. If parents aren't available, full siblings of the parent would be the next best bet.

So, the answer to this question is yes, this tool can be useful in determining whether you have Native ancestry or not.

Genealogy Gems: News from the Fort Wayne Library No. 68, October 31, 2009. Technology Tip of the Month--Photo Restoration with Adobe Photoshop, Version 9.02: The Nitty Gritty I by Kay Spears

The next few articles will cover some basic tools used in photo restoration: contrast/brightness, hue/saturation, feathering, layers and cloning. These tools should be in all photoshop applications, not just Adobe Photoshop. The procedures for using them may vary in each program, but the function of the tools will be the same.

To begin, remember that what you see on the computer screen can be deceiving. There are a number of things working against your eyes – the light coming in the window, the calibration of the computer, and the type of computer used. The same image will appear darker in Windows, lighter on a MacIntosh. Sometimes what you print will not be the same as what you see on your screen, especially if you are trying to restore color photographs. Just remember that each computer is different. And be patient.

When I'm restoring photos in Adobe Photoshop, I always have the Toolbox and Layer palette dialog box open on my work area. The Toolbox has all the mouse/cursor tools on it: zoom, movement, clone, erase, select, crop, etc. The Layer palette dialog box allows you to view and work with different layers. Working with layers is a bit more complicated, but we will do a quick walk-through later.

First, evaluate each photo, deciding what needs to be done. Beginners should start with the simplest fix

and work up through the more complex problems. For me, the easiest problem to fix is the faded photograph. Save the scratches, watermarks and cracks until later. To handle fading, Adobe Photoshop provides some Auto correction features: auto Level and Auto Contrast, located under image>Adjustments. Just click on them and voila, the image is no longer faded. The limitation with using the Auto tools is that you don't have any control over the amount of fade correction, so learn to use the Brightness/Contrast tool also located under Image>Adjustments. When the Brightness/Contrast tool dialog box is open, make sure you check the preview check box; in fact, make a habit of always checking the preview box for any dialog box that you may use. This allows you to watch the changes as you progress. When adjusting the Brightness/Contrast dialog box, use either the slide bars or type in the numbers. For beginners, play with the slide bars until you are used to them, then click OK. To go beyond the basics, there are also Curves, Shadow/Highlight and Exposure tools.

At this point, I recommend you print the corrected image. If you like the way the photograph looks when printed, save it. Remember, you do not want to overwrite the original image, so use "save as" to save the corrected image in a different file. When I restore an image, I always work from a copy and not the original. You may also want to invest in some gloss or matte finish photographic paper, which can be purchased at Office Depot, Staples or most any craft store. I recommend the finished photograph be printed on a laser printer. Even though the color of a desk jet printer is more vibrant, the laser printer ink is permanent and does not run or spot if any moisture gets on it. Next article in the Nitty Gritty: Cloning.

Last month, at the end of my article on James of the Manor of Moreland, I finished with "I hope that enough information from readers will come in that we can run a follow up in the October issue." The follow up follows within the box.



Now that we are finished with the follow up, let's look at our James and Martha (Hollowell).What do we know about our James II?

The following four paragraphs are from *Hawkins Family from Wilts Co., England to Tipton Co., IN...*, by my father Harold T. Hawkins. Sourced as copied from Hawkins Files-Indiana State Library:

James and Martha (Hollowell) Hawkins first lived near Abington, PA, migrated to Loudoun Co., VA, then to the "Back-Country" in SC. It is said that James and family lived in Loudoun Co., VA, long enough to find that it was a good place to starve, this was by the records about 12 years.

The James Hawkins family moved to SC (perhaps in 1767)) and settled on the Broad River, sometimes called the Tyger River [These are different rivers. PAH], in what is now Union Co. not far from the forks forming the Santee River. James kept a toll bridge there [I believe this would be at Hawkins Shoals on the Tyger River. PAH]. Soon after 1767 other Quakers from NC, VA, MD, and PA came in and settled in this back-country, and the most brought up large families. They all intermarried and the area was sort of a clan, all related to each other.

Martha and some of her children transferred from Fairfax MM [VA] 30 May 1767 to Waterloo MM, SC, then to Bush River MM, and finally when it came into existence, to Cane Creek MM which was close by. It is likely that James attended services at both Bush River and Cane Creek, but there are no records of him being reinstated [See second bullet below.]. James's "Will" proven 1 Apr 1793 does show his faith in Quakers, when he directed "four honest men chosen by the religious Meeting of People called Quakers" to settle any controversies concerning his estate.

We are told that James Hawkins had a comfortable home in SC, and his "Will" tells us he accumulated about 1730 acres of land, and indicates that he had other wealth. It is said he worked continually, often from four o'clock in the morning until late at night. While in SC, raised tobacco and cotton, he owned a grist mill and a saw mill, cracked oats and rice, made his own barrels, cut the poles etc., and always kept good horses.

This James, c1715-1793, according to the late Carl Hawkins of Richmond, IN, was born about 1715 near the Delaware Rive in PA. Following is additional information with the sources as indicated.

- 1759 "James & w Martha & ch: John, Isaac, Nathan, Benjamin, Jonathan, Wm, Amos, James & Martha, rocf Abington MM, Pa. 31-3-1759;" (Hinshaw, Vol VI, p.504, Fairfax, VA MM.)
- 1762 "James Hawkins dis for habitual "drinking" 30-1-1762;" (Hinshaw, Vol VI, p.504, Fairfax, VA MM.)
- 1766 Record Book 9, p.42. Survey to James Hawkins, pursuant to a precept, dated December 2, 1766, 100 acres in Berkeley County, S. C., in the fork between Broad and Saludy the rivers, bounded north eastwardly on a branch of Broad River called Tyger River and northwesterdly part on lands laid out by the province of North Carolina part vacant and the other sides vacant. [This description would fit the 100 acre parcel stretching soutwesterly from the current Hawkins Shoals on the Tyger River. PAH] [Comment by Ralph Hawkins Bower? - Plat shows it to be north of Tyger River and west of the corner of land laid out by the province of North Carolina to Benjamin Gordon. Ralph Hawkins Bower]. [Anyone know what books these are? Phillip A. Hawkins]
- 1767 Record Book 9, p. a14. Survey to James Hawkins, pursuant to a precept dated August 4, 1767; 300 acres in Craven County, S. C. on the south side of Watree River, bounded on all sides by vacant land. [Probably in what is now Kershaw or Sumpter County.. Ralph Hawkins Bower?] [Anyone know what books these are? Phillip A. Hawkins]
- 1776 "Martha & her minor ch: Benjamin, Nathan, Martha, William, Amos & James gct Wateree MM, Kershaw Co., S.C. 26-4-1766. (Note: this fam. lived in Craven Co. S.C. & some of their records are found in Bush River MM S.C.: see H.v1,pp 1020/1031; the books of Wateree MM are lost)." (Hinshaw, Vol VI, p.504, Fairfax, VA MM.)
- 1784 Record Book B., p. 385. James Hawkins, of 96 District, S. C. on December 2, 1784 for 10 pounds buys of James Tims 400 acres of land lying between Tyger and Ennoree Rivers bounded north east of land laid out to Zechariah Easters and bounded northwest on the said Easters land

claimed by Edward Biddle said land granted to Amos Tim's sr. July 26, 1774, together with edifices, buildings, barns, stable yards, etc. buys of James Tims Jr. and Patty his wife. [Willed to Isaac and Nathan. Ralph Hawkins Bowers] [Anyone know what books these are? Phillip A. Hawkins]

- 1793 The JAMES HAWKINS will was made in Union County, South Carolina, and recorded in Will Book No. 1, page 9. It was proven 1 April 1793. The will lists Martha, his wife, and children John, Isaac, Benjamin, Jonathan, Martha, Nathan, James, Amos, and William. Land willed to his sons totals 1730 acres, plus, "the plantation whereon I now live." [? +100 acres = 1830?.] The Mills were located on the Tyger River 3.14 miles northeast of where the Union County border leaves the Tyger River towards the southwest (Hawkins Shoals is listed at 34° 31' 12.50" W 81° 31' 35.37" W). They were on 100 acres stretching to the southwest from the river. [I have copies of the will if a copy is desired. Phillip A. Hawkins]
- The Land Grant Maps in Union County show James Hawkins having owned 1859 acres, all in the southeast corner of the county, south of SC Hwy 72, on and scattered west of Cane Creek to the Tyger River with 100 acres (the mill property) stretching to the south west of the Tyger River. An additional 190 acres are shown in the names of sons John and Benjamin. [Phillip A. Hawkins, Oct 2009]

Please advise if you can provide additional information and its source. Share with me, please.

A recently found "lost ancestor" in Texas from my family of Robert Hawkins II. His name was also Robert Hawkins b. 1850 in Nashville, Davidson Co. TN. Robert III moved to Coffee Co. TN around 1866 with his widowed mother, Rosetta Inyard Hawkins. Robert married Mary Cook in 1873 in Manchester, Coffee Co. TN. They were lost until the 1900 Census of Donley Co. TX. Robert and his family were probably living in Nashville during this time with Selina Williams Hawkins, widow of my Great Grandfather Thomas James Hawkins. He was listed in the Nashville City Directory at the same address of Selina in 1882.

Robert and Mary moved with three of their children, Robert, Homer and Myrtle to Texas sometime 1882 and 1900. They had two more children after their move, Edna and William. Mary was listed on the 1910 Census of Potter Co. TX as a widow, I do not have a death date for Robert except the window between the 1900 and 1910 Census. Mary lived with their daughter, Edna and her family later in Tarrant Co. TX. There is still a lot of missing information on this family, hopefully I will find more as time passes.

Notes concerning the John S. Hawkins family:

John S. Hawkins was a blacksmith and a farmer. He was born in Kentucky as were his parents according to census records. His wife, Cassa was born in Georgia as were her parents, also according to census records. They lived in Alabama and in Mississippi and died after 1880 probably around Meridian, Lauderdale Co., Mississippi.

Vines Franklin "Frank" Hawkins enlisted in Capt. Wm. B. Turner's Company of Light Artillery at Enterprise, MS on Dec. 15 or 16, 1863. He enlisted as a private and was captured at Mobile where he was a prisoner until the end of the war.

Frank was married twice, 1st to Elizabeth Wiggins and 2nd to Celia Elizabeth Whitlock. Although I have two daughters listed from the marriage of Frank and Elizabeth Wiggins, these two daughters may be the same person. Also in the 1900 census, Frank is listed with 5 children, one of which is Joe, a female born in 1870. No other record or family memories knows of this person, so this may be an error or a child of Celia Elizabeth Whitlock by her previous marriage to Strother Matlock.

A. Luther Hawkins never knew his father and was adopted and raised by his grandfather, Vines Franklin "Frank" Hawkins after his mother married Sanders. Therefore, on some census records he is listed as the son of Vines Franklin Hawkins.
