Further Adventures with Adobe Photoshop: Levels Eyedropper Tools, by Kay Spears

The Levels Eyedropper tools provide just one method for restoring the color in old photographs that are faded and have developed a yellow or pink cast.

For this lesson, we are going to use the Levels tool located in the Layers Palette. There are two ways to open the Levels tool: by going to the menu bar and clicking on Image>Adjustments>Levels, or by opening the one in the Layers Palette. When you run your cursor along the icons located at the bottom of the Layers Palette, a pop-up box should appear that says "Create new fill or adjustment layer." Click on that icon, then click on the word Levels to open the Levels dialog box. In that dialog box is a histogram, which looks like a graph. Right below the histogram is a sliding bar with three little triangles. Below that is the output levels bar and over to the right, above the "preview" checkbox, are three little eyedroppers. It is these eyedroppers that we are going to talk about, because they can do magical things to your old photographs.

First, study your photograph. Imagine which areas might have been neutral or gray. Go to the middle eyedropper (gray point) and click on it. Your cursor's appearance will change to an eyedropper. Click the eyedropper on the area in the photograph that you believe to have been a neutral color. If you guess correctly, the unwanted color cast will be removed. At this point, your photograph may look the way you want it to and no further repair will be necessary. However, we have two more eyedroppers. The left eyedropper is the black point and the right eyedropper is the white point.

Study the photo again and locate what you consider to be the darkest point. Click the left eyedropper (black), then return to the photograph and click on the area you consider darkest. The photograph should become quite

vibrant at this point. You may do a similar thing with the right eyedropper (white) on the lightest point or, if you are happy with the results already, you can stop at this point. Or you can use the white eyedropper first, then the black. A word of warning – you do not want your black and white points to be pure black and pure white, so you may have to tweak the photo with the slide bars under the histogram. Since we've used the Layers Palette, if you don't like the results, you can take this Levels layer and drag it to the trash bin without altering your photograph.

You can apply this eyedropper fix to black and white photographs too. Remember that every photograph is unique and each fix yields a different result. So, if you want your skills to improve, experiment and practice are the best ways to learn Adobe.

Reuben Hawkins, son of William and Elizabeth (Wall) Hawkins of Orange Co., VA, died without a will. His son Roddy handled the sale of the land. Following is a transcription of that document. It contains the names of his children. Sincerely, Bob Hawkins-Group 2

This Indenture made the twenty seventh day of August eighteen hundred and thirteen by and between Roddy Hawkins of the County of Orange and State of Virginia for himself and also and also attorney in fact for his brothers and one sister in the State of Kentucky viz William Hawkins, Elisha Hawkins, Elizabeth Hawkins, Arculus Hawkins and Reuben Hawkins and also Esquire Jenkins and Lucy Jenkins his wife and Moses Hawkins each of the County of Orange and State of Virginia and Rebecca Hawkins of said County Orange and State of Virginia for herself and also guardian for the four younger children of Reuben Hawkins decd. viz Uriah, Milly, Benjamin and Sally all of the one part and William Keaton of the County Orange of the other part witnesseth that for and in consideration of the sum of six hundred dollars lawful money of Virginia to them the said Roddy Hawkins in hand paid as well for the benefit of those above mentioned for whom he acts as for himself and Lucy Jenkins and Moses Hawkins for themselves and likewise the said Rebecca Hawkins for herself and for the benefit of those for whom she acts, the receipt whereof they the above acting parties do by these presents acknowledge, have granted, bargained and sold, and as by these presents grant, bargain, sell and deliver unto the said William Keaton his heirs or assigns forever one certain tract or parcel of land situate lying and being in the

County Orange on the lower flat run and is the tract of land of which the father of the above named family of Hawkin's died seized and contains by survey ninety seven acres and three quarters be the same more or less, and is bounded as follows towit: Beginning at a corner between two white oak stumps in a meadow on the said flat run, thence south twenty one degrees west twenty six poles to a stone on the north side the Fredericksburg road thence with said road eighty six poles to two red oak bushes on the same side the road on a hill, thence south sixty one and one half degrees east thirty eight poles to five Spanish oaks on the south side said road, on a hill, thence north twenty eight and one half degrees east one hundred and six poles to several red oaks on a ridge, thence north sixty one and one half degrees west one hundred and twenty nine poles to a hickory on the said flat run by a large poplar stump in Frances Jones's line, thence up the said run with its east fork to the beginning. To have and to hold the hereby conveyed ninety seven and three quarter acres with all its appurtenances privileges and advantages to the only proper use and behoof of him the said William Keaton his heirs and assigns forever and they the above named family of Hawkins' and their heirs in their several capacities above mentioned in covenant agree to and with the said William Keaton his heirs that they will warrant and forever defend the right, title and interest of the above mentioned tract of land with all its appurtenances to him the said William Keaton his heirs and assigns against them the said Hawkins' above mentioned and their heirs and all and every other person or persons whatsoever. In Witness whereof they have hereunto set their hands and seals this day and date first above written.

The Commonwealth of Virginia, to Thomas Row and Thomas Grasty Gentlemen Justice of the peace of the County of Orange greeting: Whereas Roddy Hawkins for himself and also as attorney in fact for his brothers and one sister in the State of Kentucky viz William Hawkins, Elisha Hawkins, Elizabeth Hawkins, Arculus Hawkins and Reuben Hawkins and also Esquire Jenkins and Lucy his wife and Moses Hawkins of the County of Orange and Rebecca Hawkins for herself and also guardian for the four younger children of Reuben Hawkins deceased viz Uriah, Milly, Benjamin and Sally by their certain indenture of bargain and sale, bearing date the 27<sup>th</sup> day of August 1813, have sold and conveyed unto William Keaton one certain tract or parcel of land situate lying and being in the County of Orange on the lower flat run and is the tract of land which the father of the above named family of Hawkins' died seized and contains by survey 97 acres and three quarters, be the same more or less and bounded as described in the said Indenture and whereas the said Lucy cannot conveniently travel to our County Court of Orange to make acknowledgement of the said conveyance- Therefore we do give unto you, or any two or more of you, power to receive the acknowledgment which the said Lucy shall be willing to make before you of the conveyance aforesaid, contained in the said Indenture which is hereunto annexed and we do therefore command you, that you as personally go to the said Lucy and receive her acknowledgment of the same, and examine her privately and apart from the said Esquire her husband, whether she doth the same freely and voluntarily without his persuasions or threats? And whether she be willing that the same should be recorded in our said County Court? And when you have received her acknowledgment and examined her as aforesaid that you distinctly and openly certify us thereof in our said court under your seals, sending then there the said Indenture and this writ: Witness, Reynolds Chapman Clerk of our said court at the courthouse the 7<sup>th</sup> day of October 1813, in the 38<sup>th</sup> year of the Commonwealth.

P. C. Spencer book shows James probably born in PA, 25 Jan 1756. "His father was named Executor on the grandfather's will in 1755. James is born the first month of 1756, and ten months after his birth the family are recommended by Falls to Abington."

"At the death of his father James was unmarried. He inherited the plantation where his parents lived. His widowed mother Martha lived with him..."

James, but not his family, was disowned at Cane Creek, SC. He was reinstated at Caesar Creek, OH on 25 Apr 1812.

Page 521, Cemetery Records of Clinton County, Ohio state that James was born 1-25-1756.

James Hawkins was born in Loudoun County, Va., January 23, 1756. He left there when a young man, and settled in Union County, S. C., and about the year 1792, married Sarah, a daughter of John and Dinah Wilson, and sister of the wife of Samuel Spray. On the 14th of March, 1795, Ruth, their first child, was born, and followed by Dinah, 22d, 11th, 1795, and Jehu, 30th, 10th, 1796. In 1806, he too took up the line of emigration, and landed here in the same year. He purchased of Samuel Spray 144 acres off the northeast corner of his tract of land, the consideration being \$4 an acre, and erected thereon a log house and began the clearing of his land. On 1st day, 4th 1808, a son, Benjamin, was added to the family. On the 1st, 6th, 1810, James, and 23d, 5th, 1813, Amos, the latter of whom now owns and lives on the old place. John lives in Indianapolis; the rest have long since died. [page 654, History of Clinton County by A. H. Harlan]

Abraham Hawkins and Matthew Hawkins, son of Nathan Hawkins, whose mother was Rebecca Hawkins (d/o Matthew Hawkins who married Gain, Boring and Frazier) were together in North Carolina, along with Benjamin Hawkins, during the Revolutionary War. Nathan and Abraham were both grandsons of Matthew Hawkins, son of John Hawkins, mariner. Matthew Hawkins, grandson of Matthew Hawkins, son of John Hawkins, mariner, had previously been a militiaman in Fincastle County VA Militia in the 1770's. In Fincastle Co VA, Matthew Hawkins is listed in David Looney's Company along with his father, Nathan, and brother, Aaron. Matthew and Abraham are also listed as Loyalists. Matthew, Aaron and Nathan Hawkins participated in the Battle of Point Pleasant and they are also listed in Lord Dunmore's War in the Valley of VA. Matthew signed the Watauga Petition in 1776 – considered by historians to be the first Declaration of Independence on North American soil. These records are in the Library of VA. Abraham, son of Abraham, had settled in Lawrence Co IN by 1820. Before 1830, the rest of his family went to Lawrence Co IN.

Interestingly, Nathan Hawkins was listed as a Loyalist and needed to come to court to show why his property should not be confiscated after the Rev War was over – the War went on and on in the Carolinas where it was a Civil War. Nathan had been dead several years and thus was not able to come to court.

Matthew Hawkins, s/o John Hawkins, mariner of New England, and his wife, Mary, died ca 1705 Baltimore Co MD. His will, dated 14 April 1705, named brothers, Joseph and Thomas, his own sons, Matthew and Augustine, daughters, Mary, Anne, Dinah, and Rebecca. He leaves the raising of his children to his brothers, Joseph and Thomas. Thomas is unable to fulfill the request and Joseph, raised his orphaned children. Thomas died shortly after.

In the William Wilkins Manuscripts, housed in the Maryland Historical Society in Baltimore, Maryland, it is mentioned that Rebecca died ca 1723. This information is repeated throughout the years and never checked on. Not only did she not die but she lived on and married William Gain, James Boring and John Frazier, whom she outlived. She was raised in the home of her uncle, Joseph Hawkins, as an orphan of her father, Matthew Hawkins, brother of Joseph. We know this is the same Rebecca Hawkins Gain Boring Frazier because we have the birth record of her son, Nathan Hawkins, and we have Perogative Court Records of Maryland stating that she and Nathan came into court concerning the burial of James Boring. We also have her settling the affairs of William Gain as Rebecca Boring, and settling the affairs of James Boring as Rebecca Frasier. Nathan refers to James Boring as his "now father-in-law" meaning his father according to the law when his mother was married to him. The court wanted to know where they buried him. (At the end of Bladen's lane/line.) We know the father of Nathan Hawkins, son of Rebecca Hawkins, d/o Matthew Hawkins, is of the same male line as her father, uncles, brothers and cousins through the line of the son of Matthew Hawkins son, Matthew's son, Abraham, who matches the descendant males of his sister, Rebecca's son, Nathan. Nathan Hawkins' birth record is in St. Paul's Church Records, Baltimore Co MD.

Three sons of Robert Hawkins and his first wife, Elizabeth living in Albemarle Co. Va based on the 1820 Census.

Robert Hawkins remarried after Elizabeth's death. He moved with his second wife, Sarah Francis Gillion and her family to Sumner Co. TN. Based on the 1810 & 1820 Census and the marriage of Abner Hawkins and Julia Hoggart in Charlotte Co., Robert and family were in Charlotte Co. as they traveled to Tennessee.

In the 1820 Census of Albemarle Co., VA:

Abner Hawkins: 1 male under 10; 1 male under 16; 3 males 16-26; 1 female 16-26

Allen Hawkins: 2 males under 16; 1 male 16-26.

My theory based on these findings are that Abner and Allen were the males 16-16 on their lines – Abner's age would have been about 25 and Allen's 23. Robert (II) their brother born about 1805 was one of the total of 3 males under 16.

No males were listed with Robert (I) in Charlotte Co. Allen Hawkins stayed in Albemarle Co. VA until his death in 1885. Abner and his wife Julia moved to Nashville, TN around 1822. I believe that Robert (II) moved with Abner and Julia to Nashville. Abner died in 1828, believed to have been poisoned by a female slave.

Robert II married Rosetta Inyard in 1829 and is listed on the 1830 Census for Nashville, Davidson Co. TN with 1 female age 18 and one male under 5. His first son, my great grandfather Thomas James Hawkins was born in Aug of 1830.

These findings lead me to believe that Robert II, my great great grandfather moved with Abner and Allen to Albemarle Co. VA and then moved again to Nashville, TN with brother Abner. All of them were masons as was their father, Robert I.
