## NPE's (non paternal event)

There are a number of reasons that a male's surname may differ from that of his biological father, including

- 1. illegitimacy, both in-wedlock, and out-of-wedlock, when a young boy is given the name of his mother or her husband.
- 2. Formal adoptions or name changes (since the 1850's) (and earlier in some countries by a husband or widower, so that he could inherit land from his wife or father-in-law).
- 3. <u>Unrecorded adoptions or name change.</u>
  - a. An orphan was given the surname of his guardian (e. g. a neighboring family).
  - b. A young boy was given the surname of his widowed mother or his stepfather (especially pre 19th century, and in Scotland where wives retained their maiden names).
  - c. A migration, naturalization or administrative change led to the Anglicizing of a surname;
- 4. <u>Before surname became strictly hereditary</u> (typically 12th-18th centuries).
  - a. A boy took the patronymic of his father.
  - b. A boy took his mother's surname when she had higher status than his father (e.g. Oliver Cromwell);
  - c. A man became known by his alias name (i.e. "aka"), such as his trade- or nick-name, or the name of the place from which he had migrated, or in which he now lived.

Considering all the above, we should not be terribly surprised if we were to find that we have a different surname from some where in our past. A large number of participants that find they match a different surname rather than their current surname, need remember that their NPE could have happened a very long time ago.

From a DNA perspective of our Hawkins family history we view/classify NPE's as either an

- introgression (i-NPE), where a participant will bear the project surname, but bears the DNA signature of some other surname.
- egression (e-NPE), where the participant will not bear the project surname, but will bear the DNA signature of one of the clusters (Groups) of the project surname. In practice e-NPE participants will probably have first joined another project that will have found them to be an i-NPE in that project.

Potentially then, one project's e-NPE will be another project's i-NPE, and vice-versa.

Technology Tip of the Month--Using the Mask Tool in Adobe Photoshop by Kay Spears

Have you ever seen old photographs in a montage, or a photograph in which the person in the image seems to separate from the background, and wondered how that was done? Have you ever wanted to assemble a montage of your own family photographs? This article will describe one way to use the Adobe Photoshop Mask Tool for creating such visual effects. Adobe Photoshop Elements software older than version 9 does not have this tool. We will explore masking in older versions next month.

The Mask tool is one of my favorites in Adobe. I can get a multitude of amazing effects using it in combination with other tools in the program. Let's pretend that I want to use a photograph of my grandmother in a family history, however, there are three other people in the picture. I want the focus of the photo to be my grandmother, so, I've decided to colorize her. There are a variety of ways to do this. I could just "paint" her, but I don't like painting old photographs. I could also use my Erase tool, and erase everything around her. Instead, I am going to use the Mask tool in conjunction with the Layers tool. First, open up your photograph. Make sure that you have the Layers palette open. On the Layers palette, change the image from Background to Layer by right clicking and choosing "Layer from Background." You will now see the word Layer on the palette. Next, right click on that layer and choose "Duplicate Layer." There should now be two layers containing the same image. Select the top layer and colorize it by going to Image>Adjustments>Hue/Saturation and choosing "Colorize." By adjusting the slide bars, you can make the top layer any color. I'm making mine blue. Click OK.

At this point, I have two layers – a blue one and the original black/white or sepia photograph. We are ready to apply the Mask tool. Make sure that the blue layer is selected. In the lower left hand corner on the Layers palette are some small icons. In my version of Photoshop Elements, the icon I want is third from the left, the "Add Layer Mask" icon. It looks like a rectangle with a circle in it. If you hold the cursor over it, a pop-up button appears saying "Add Layer Mask." Click on this icon and look at the blue layer. A white box should be beside the image thumbnail. There are now two things on this one layer – the mask and the image.

The following step is very important. To make sure that the mask works, the color palette's "Foreground Color" must be black. Access the color palette by clicking on the Tools bar. At the bottom of the Tools bar are two overlapping squares. To make sure that the top one is black, click on it. A Color Picker will open. Look at the values next to the letters R, G, and B. They should all say 0. In Adobe Photoshop, these three values are always 0 for black, and 250 for white. So, set all three to zero. Now, select the Brush Tool from the Tools bar and change its size and opacity settings as desired. Your cursor will change its shape accordingly. Return to the Layer Palette and on the top layer, click on the white rectangle associated with the mask. Now, not only is your cursor a Brush Tool, but your Mask is active. Go to the photographic image and apply your Brush to the areas you want to cover up or "mask." You should start to see the bottom layer coming through. In my case, I am "masking" everything around my grandmother. When I'm finished, my grandmother will be the only object in the photograph that is colorized.

You can create numerous effects with the mask by incorporating different layers of scenery, people or filter gallery effects. Be adventurous and experiment with the "masking" tool. Changing the Color Picker's R, G, and B values back to white, or 250, and brushing over the area will return the image to its original state. You can also delete just the mask by dragging it to the Layers Palette Trash Bin.

Technology Tip of the Month--The Microsoft Word 2010 Ribbon: File Tab by Kay Spears

The File tab is the very first tab on the ribbon and contains several useful features. Under the Options feature, you will find most all of the settings for Word. Altering these settings will change the appearance and operation of Microsoft Word, so tread carefully. However, do take a look at the choices available. Some of the things you can change under Options are the spacing between words, the auto-correct features, spell checking, how documents print, etc.

Also located on the File tab is the Recent feature. This displays the last 20 Word documents and folders you have had open. Located to the right of each document or folder is a Thumbtack. Enabling this Thumbtack pins that particular document or folder to the top of the list.

The Save and Save As options are also located on the File tab. The Info tool will display basic information about the document that you have open, including who created it, when it was created, and what permissions may be attached to it.

The Print tool on the File tab features some interesting improvements. When you click on the Print button, a print view of your document is revealed on the right hand side of the screen. The number of pages in your document is shown at the bottom. At the top left of your preview document is the printer icon. Beside it, you may indicate the number of copies you want to make. The default printer connected to your computer is listed below the printer icon and a drop down arrow allows you to select an alternate printer, if one is available. The Settings appear below the listed Printer and may vary depending on your printer drivers and the capabilities of your printer. For instance, some printers have the capacity to duplex, or collate and staple, while others do not. Drop down arrows allow you to change the default settings.

For documents longer than one page, the printing options are Print All Pages, Print Selection, Print Current Page, or Print Custom Range. One of the features I like is the ability to select and print a single page from the preview document without flipping back and forth between File and Home. For instance, after clicking on File>Print, scroll to page three in the preview document and select Print Current Page, then Print. Only page three will print.

So, let's say a fond farewell to the Ribbon.






This month I am including the pictures of the Hawkins in

#### The Weston Cemetery.

This Cemetery is located in Fairmount Township Section #26, Range \*E. T 23 N. The Jesse Holloway farm was the southwest 1/2 of the southwest 1/4 of Section # 26. In the 1990 Plat book there is still a G. Holloway on part of this land. But, at this time I am unable to determine exactly where the monument is.

#### Fairmount News, 29 October 1932, p 4:

"Fairmount, Oct. 19. One hundred years ago, John Weston, one of the first settlers on Fairmount Township, built a cabin on what is now the Jesse Holloway farm, two miles east of this city, to which he brought his wife and children. One year later while walking in the woods near to cabin with a woman companion, Mrs. Weston saw what appeared to be a bright light in the sky. She interpreted this as an omen, foretelling her own death within a short time, and told her companion that she wanted to be buried on the top of a ridge, consisting of the only high ground in that vicinity, and even went so far as to designate the exact spot for her grave. In just a day to the year Mrs. Weston died, and was buried on the ridge on the eastern border of what is now known as the "Prairie", in a casket which consisted of a large log split with the center chopped out sufficiently to contain a body. A vault was constructed in the ground, to which the log casket was consigned and across the top of this vault, hand hewn clapboards were placed to provide the lid of the crude rough log.

Yesterday, W. J. Lewis, David G. Lewis, of this city, and J. A. Lewis, living east of town, went to the lonely grave on the Holloway farm, erecting a marker, suitably lettered, to the memory of their great aunt, who for many years has slept above what at one time was an arm of Lake Galatia, several miles northeast. All of the above historical facts came down to these men through family tradition, and the erection of the marker for Mrs. Weston, is a culmination of a plan which they had in mind for some time. The marker, constructed of cement, is a sturdy design and so erected that it is expected to remain in place indefinitely. It is said that nearby in after years, some six or seven other bodies of pioneers were interred near Mrs. Weston, but all trace of them have been lost in the intervening period."

The monument was erected 16 October 1932. Mrs. Nellie Weston was the wife of John Weston, and she was a sister to David Lewis, Jr.

John Weston, b ca 1795 carter County, Tennessee, died 26 April 1845, Conway County, Arkansas. Eleanor Lewis, b 5 May 1797, Sullivan County, Tennessee, died 22 October 1836, Fairmount, Grant County, Indiana, buried Weston Cemetery.

Eleanor (Lewis) Weston was the daughter of David Lewis of Franklin County, Indiana. David was a brother to George Lewis, Jonathan Lewis, Mary Lewis (husband, John Barber) and Eleanor Lewis (husband, Moses Barber) Dearborne, County, Indiana.

The eldest child of John and Eleanor Weston was David Weston. David Weston was born 9 July 1820, Franklin or Hancock County, Indiana. He died 19 Dec 1875 Champoeg, Oregon. He married 27 January 1852 St. Paul Oregon Territory, to Mary Sinclair, b Fall of 1842 at Ft. George (Astoria) Oregon Territory. She died 21 Jan 1884 Champoeg, oregon. She was the daughter of Thomas Sinclair/St.Clair and Ellen Cullallcin. Ellen Cullallcin was the daughter of (Call-cino Che-wa-ca-pa) Chief Cowhicalas of the Chinook Tribe.

Nathan Hawkins and Ruth Cole were the parents of Mary Elizabeth Hawkins who married David Lewis, mentioned above. Mary Elizabeth and David Lewis left Sullivan County, Tennessee through the Cumberland Gap and came to Franklin County, Indiana. They entered land on the Big Salt Creek in Franklin County. David Lewis and family, his brother George and his family, with their two sisters and their husbands - Jonathan Webb and Moses Barber - left Sullivan Co., and on their way, stayed at their Uncle John Crockett's cabin. The next day, John, Davy's brother, took them a days trail toward Indiana. David Lewis, Jr. was a son of Mary Elizabeth Hawkins and David Lewis.

## Timeline for Nathaniel Macon Hawkins Created by Renate Sanders (gg-granddaughter)

**1831** - Nathaniel is born to parents Philemon and Jacobina (Sherrod) Hawkins in Louisburg, Franklin County, NC.

**1840** - Age 9 - At home with parents in Franklin County.

**1850** - Age 20 - Nathaniel lives at home with his parents and 6 siblings; Arch (22), Madison (21), Lucy (19), Fanny (17), Mary (12), Benjamin (10). Nathaniel's father, Philemon, is enumerated as "Hotel Keeper". Nathaniel is a "farmer". (None of his siblins are noted to have jobs, which is interesting. Also, I wonder where the farm was?)

Others listed are most likely boarding in the hotel, and at least some of them appear to work there. They are: Sidney Jeffries (Clerk), Samuel Perry (physician), Edward Lawrence (Surgeon Dentist), Ianu?z Wynn (17), Edward Ratley (table servant)

**1860** - Nathaniel lives in Louisburg with his mother (widowed) and 3 siblings, Fanny, Mary, and Benjamin. His occupation is "*Negro Trader*". His mother, Jacobine, is now the hotel keeper. Nathaniel owns real estate valued at \$625, but has a personal estate valued at \$8140. Jacobine's property is valued at \$12,050, and personal estate at \$4000.

Nathaniel's brother, Madison (a farmer), and his wife, Truxilla, live right next door.

Slave schedule shows Nathaniel as <u>owning</u> only *one slave* - a 15 year old female. (This is almost certainly, Anna Green, who will become the mother of Nathaniel's children.) The slave is enumerated in Franklinton, and

appears to reside on some type of property with slaves of other owners. (Perhaps a work-farm of some type?)

1864 - John Wesley Green is born to Anna.

#### 1865 - Emancipation of Slaves

1868 - Elizabeth "Bettie" Green is born to Anna.

**1870** - Nathaniel (enumerated as "Nat"), remains single, and lives alone, in a neighborhood surrounded by blacks. (Anna and the children are listed in a different household, several pages away.) His occupation is now listed as, "trader". His real estate is now valued at \$4850, and his personal estate at \$1200. (Family lore says that Nathaniel "put Anna and the children up" in a nice two-story home, which his family kicked her out of after his death, so perhaps that house is a part of that real estate which is being accounted for here.)

1871 - Annie B Green is born to Anna.

**1873** - William Adam Green is born to Anna. \*Confusion - Nov. 5, 1873 Bastardy bond implicates J J Murphy as the father of Anna's child. Nathaniel signs the document (presumably as a witness). On the same date, in the exact same language and handwriting, another bond implies that Nathaniel has fathered a child with Alpharetta Dent, and is signed also by JJ Murphy. Alpharetta Dent and her children live on the same land as JJ Murphy, who is single, and all of her children are mulatto, just as Anna's are. There's some tom-foolery going on here!

1876 - Mary Helen "Pidgy" Green is born to Anna

**1879** - **Esther Green** is born to Anna. (Family says that Esther may not have been Nathaniel's, because she was darker-skinned, but until proven otherwise, I will count her as his.)

Nathaniel dies. (Cause is not yet determined, but he was under doctor's care.)

## Evidentiary documents related to Nathaniel Hawkins: (Copies in my possession)

\*Davis & Roads, January 4, 1865 - *Promissary note* to pay \$585.00 for hire of negro man, Jess for the year. Signed by NM Hawkins, M. Hawkins, and PB Hawkins (Settled as part of estate on Oct. 28, 1881. Paid in full (\$11.75)

Nov. 1872 - Promissory note: Mr. Davis Spencer to Mr. Nat Hawkins for CJ Outlaw for carrying telegram at the death of Mr. Reid.

\*1873 - "I CJ Outlaw paid Nat Hawkins \$2.00 in money. The said Nat Hawkins was on his way to Raleigh and promised to credit my note with the same on his return."

1879 - 1882 - Statement of account with O.L. Ellis, M.D: Shows Nathaniel's care and prescriptions in July 1878, and Feb. 1879. Then shows 23 months interest and full payment of \$9.65 by Nathaniel's estate in 1882. (There are possible clues abt Nat's cause of death. On 2/24/1879, he was charged \$5.00 for a consultation with Drs. Foster and Clifton. On that same date, he was billed \$1.00 for "bleeding self". (This is the same date as the charge for the burial suit, so my guess is that Nathaniel died that same day, perhaps right there in the doctor's office.

\*Yarborough & Co. - Feb. 24, 1879 - Bill for burial suit (\$23.50) - See below.

\* Letter of Administration - Franklin County Probate Court, March 29, 1879: This document states that

Nathaniel died intestate, and names Phil B. Hawkins as administrator of his estate. (This is Nathaniel's cousin, Philemon, who married N's sister, Fanny.)

\*Franklin County Superior Court (no date/year given) - PB Hawkins, admin of NM Hawkins against PB Hawkins and wife, Fanny Hawkins, Mary M Hawkins, BF Hawkins, Madison Hawkins and others, and BF Hawkins guardian ad litem for the infant defendants, Henry M. Hawkins, Nathaniel Williams, Hawkins Williams, and Mary G. Willaims. (This an answer to a complaint, apparently in an ongoing court case to settle Nathaniel's estate. As yet, I've not located the original complaint.)

\*Receipt for payment to Yarborough & Co. from estate of NM Hawkins (for burial suit) - Sept 22, 1889.

Undated: Received of PB Hawkins, admin for NM Hawkins, \$5.00 in payment offer for appearing as attorney for the guardian ad litem for the infant Cris(?) Outlaw (?) in a proceeding to (??) real estate assets. BB Massenburg

1. **John Daniels Hawkins-**1 was born in 1822 in Marshall County, Tennessee. He died on 10 Sep 1875 in Marshall County, Tennessee.

**Nancy Hutchins Bills** daughter of Daniel Gersham Bills and Rachel Summers was born in 1818 in Tennessee. She died before 22 Jul 1897 in Alabama.

John Daniels Hawkins and Nancy Hutchins Bills were married on 16 Sep 1845 in Marshall County, TN; by Wilson P. Davis, J.P.[1]. They had the following children:

- i. 2. **William Daniel Hawkins** was born on 01 Jul 1846 in Marshall County, Tennessee. He married Laura Bell Enochs on 03 Jul 1887 in Lincoln County, Tennessee. He died on 13 Sep 1907 in Tennessee.
- ii. 3. **James Amos Hawkins** was born on 09 Jan 1848 in Marshall County, Tennessee. He married Martha Elizabeth "Matt" McAdams on 29 Oct 1868 in Marshall County, Tennessee[2]. He died on 19 Oct 1922 in Marshall County, Tennessee.
- iii. 4. **Leroy Cratus Hawkins** was born on 12 Apr 1850 in Tennessee. He married Eliza E. Gilbert on 02 Aug 1885 in Marshall County, Tennessee[3]. He died on 06 Aug 1917 in Marshall County, Tennessee.
- iv. 5. **Mary E. Hawkins** was born on 17 Sep 1852 in Tennessee. She married Robert A. Adams on 07 Dec 1876 in Marshall County, Tennessee[4]. She died on 04 Jul 1928.
- v. **Sara E. Hawkins** was born in 1855 in Tennessee. She married Wilson B. Cochran on 19 Jan 1871 in Marshall County, Tennessee[4].

- vi. 6. **Caldora Hawkins** was born in Jun 1856 in Tennessee. She died in 1932 in Marshall County, Tennessee.
- vii. 7. **John Thomas Hawkins** was born on 11 Jun 1859 in Lewisburg, Marshall County, Tennessee. He married Annie Catherine McAdams on 20 Nov 1884 in Marshall County, Tennessee[2]. He died on 24 Feb 1935 in Ardmore, Carter County, Oklahoma.
- viii. 8. **Ewell Lee Hawkins** was born on 09 Apr 1863 in Marshall County, Tennessee[5]. He married Mary Lu McAdams on 24 Dec 1885 in Marshall County, Tennessee[2]. He died on 10 Jan 1936 in Petersburg, Marshall County, Tennessee[6].

#### Generation 2

2. **William Daniel Hawkins-**2 (John Daniels-1) was born on 01 Jul 1846 in Marshall County, Tennessee. He died on 13 Sep 1907 in Tennessee.

**Laura Bell Enochs** daughter of Robert R. Enochs and Martha E. Smith was born on 07 Jul 1855 in Tennessee. She died on 06 Aug 1907 in Tennessee.

William Daniel Hawkins and Laura Bell Enochs were married on 03 Jul 1887 in Lincoln County, Tennessee. They had the following children:

- i. **Ida Abigal Hawkins** was born on 06 Feb 1886 in Marshall County, Tennessee. She married Jesse Laurens Battle on 27 Sep 1910 in Pasco County, Florida[7]. She died on 05 Oct 1953 in Wheaton, DuPage County, Illinois.

- ii. **Roy D. Hawkins** was born in Jan 1888 in Tennessee. He died on 02 May 1911 in Atlanta, Georgia[8].

- iv. **George Copeland Hawkins Sr.** was born on 09 Apr 1892 in Flintville, Lincoln County, Tennessee. He married Ora Lee Damron on 19 Jun 1911 in Winchester, Franklin County, Tennessee[9]. He died on 25 May 1979 in Gadsden, Etowah County, Alabama.
- v. **Newton Jenkins Hawkins** was born on 02 Nov 1896 in Flintville, Lincoln County, Tennessee. He married Gladys Pearl Moody on 27 Feb 1916 in Lake County, Florida. He died on 30 Jan 1983 in Fort Myers, Lee County, Florida.
