

- MEMBERSHIP AND SUBSCRIPTIONS: HAWKINS HERITAGE was begun with the hope of identifying the parents of James and Margaret (?)
  Hawkins, b. c1765 and 1768 in VA. Vital Statistics show that they lived in Stafford County, VA from 1793 until 1825, when they emigrated to Clark County, KY. One son, John R., married into the Hawkins/Bourne line, which may be a connecting Hawkins branch of the above James. Because of an apparent need for "group" research, our publication is now open to descendants of all Hawkins lines.

Individual Membership and subscription is \$12 per year. Contributing Membership and subscription is \$20 per year (may vote).

Subscriptions begin with the <u>April</u> issue. Subscribers during the membership year may receive back issues of the <u>current</u> year or begin with the next year and pay for any single back issues. Back issue are \$4 each. #### Dustin O. Hawkins

Columbus, Ohio August 9, 1992

Hello!

My name is Dustin Hawkins, H.H. member, and I would like to

tell you about myself.

I was born and raised in Cincinnati, Ohio in the home of foster parents. Our father died when we were young and our mother was very sickly and could not properly care for her children. In time mother recovered and moved to Columbus, Ohio.

Mother would mention every so often that her ancestors on her father's side were of American Indian descent.

When I became much older, I decided that I wanted to find out something about this Indian ancestry. This was to be my first attempt at genealogy and I did manage to get back to the early 1800s in Pennsylvania and the Delaware and Cherokee Indians that lived in that area. The name Eveland was determined to be the Cherokee English name of her ancestor.

Mother told me that if I wanted to find out about my father's ancestors, I would have to contact our cousins in Sullivan and

Vigo Counties, Indiana.

This I did and this relative gave me quite a bit of information. I found out later through another relative that this genealogy was not in proper order. But we got things straightened out OK. This was in the year 1958 and I've been at it ever since.

My father was Dustin O. Hawkins, Sr., born Sullivan, IN. His father was Phillip Thomas Hawkins, born Sullivan, IN. His father was Samuel Kilby Hawkins, born in either Mercer Co., KY or Culpeper-Madison Counties, VA. My grandfather Phillip had a brother named Samuel Kilby Hawkins.

I was in the Army Air Force, then the USAF for 15 years, leaving that service in 1960. In 1975, I was employed by the Schuler-Luhart Manufacturing Co., makers of Hydraulic presses, and

left that company and retired in 1991.

My wife, Marie and I had two boys, now grown and have one grandchild named Robert W. Hawkins, Jr.

Sept. 10, 1872 in Franklin CO and d. there on June 4, 1962. She was a housewife and a Protestant and was buried at Peak's Mill. Her parents were James Thomas Wilson and Ann M. Christopher. Their children were: Clara M. b. Aug. 1, 1904 in Franklin Co. She died of T.B. in June, 1921 and is bur. in Bloomington, Franklin CO. and is buried in Bloomington. She mar. Eliza Jane Wallace on Aug. 5, 1865 in Franklin CO. 4. Mason B. was b. Sept. 9, 1837 in Franklin CO, and mar. Belinda Chisholm in 1871. He d. in Owen CO. on Dec. 8, 1921. 5. Charles M. was b. Mar. 23, 1852 in Franklin CO., KY of a lung Memorrhage. Their children were Thaddeus b ca 1839, Ann M.E. b. ca 1842, William, b. ca. 1844 and John O. b. ca 1849......1850 census in Franklin, CO., KY

Dr. Donald Birkner, of Creve Coer, MO. had done research on Hawkins families in Maryland, Virginia and Kentucky. He contributed information on his own line as well as on other Hawkins Families.

This is his Hawkins line: He is Dr. Donald Rees Birkner, a dentist, b. in 1931, the son of Inez Ione Rees b. 1901, d.1935, and Clarence Birkner. Elizameth Butler, Inex Rees' mother was b. 1860, d. 1938. She mar. Daniel Rees.

Elizabeth Rees was the dau. of Giles Hawkins Butler, b. in 1828 in KY. Giles was the son of William Butler, b. 1790-94 in Kentucky and mar. Mary Carr in 1813 in IN. William's father was Thomas Boteler (Butler) b. 1770-74) He was the son of Alexander Magruder Butler (Boteler.) Alexander and Thomas were both listed on the 1800 census of Jessamine CO., KY.

Alexander Magruder of Prince George CO.,MD d. ca 1769. His 3rd wife was Elizabeth Hawkins. They were the parents of Samuel who was the father of William Magruder who mar. Mary Fraser.

Mary Fraser's father was George, the son of Rev. John Fraser and Ann Blizzard. Ann's parents were Mary Eden and Giles Blizzard.

This may be Dr. Birkner's Hawkins connection: Henry Hawkins d. in 1699. He mar. Elinor H. in Charkes CO.,MD and their son was John Hawkins who d. in 1705. John mar. Elizabeth--- and d. in 1777.

John and Elizabeth had a son, John Jr. d. 1757. He mar. Susannah Fraser in Prince George, MD. She was the dau. of Rev. John Fraser and Ann Blizzard.

John Jr. and Susannah were the parents of Giles Blizzard Hawkins b. in 1732-d?. His son John Stone Hawkins was b. in 1734 and d. in 1763. George Fraser Hawkins, his son, d. in 1785. George F. Hawkins had a son Alexander Thomas and daughters Elizabeth Lawrence Hawkins and Susanna Fraser Hawkins.

Dr. Birkner is trying to prove that Giles Hawkins, b. 1755 in Maryland and d. 1840 in Kentucky is related to the above Hawkins. Giles Hawkins' children were: John, Thomas, George, and Giles Jr.

Dr. Birkner writes "Four of my Butler girls married Kerby men (brothers) in Jessamine CO., KY from 1799 to 1804. The father of the Kerby men was Hawkins Kerby who mar. Pricilla Hawkins Kerby who d. ca 1806 in Jessamine. He lived in Botetourte CO., VA ca 1783. There was a Sarah, Joseph and Thomas or James Hawkins in another Botetourte group and a William Hawkins by himself on a conpany list."

This information was contributed also and the source was "Our Kin" pg 708. The book is by Ackerly & Parker. "William Hawkins, the first of the name whom we have found any authentic record bought land in Bedford CO, VA in 1781. He removed to Campbell CO., VA and died there in 1793. His will mentions: wife Mary, children: William, Littleberry, Robert, Joseph, Benjamin, James and Mildred Hicks.

Robert Hawkins died in Bedsford CO., VA on July 24, 1820. He mar. Nancy Fourqueran daughter of John and Mary (Guthry) Fourqueran in Bedford CO. Feb 26, 1772. Her father , Henry Gurty consenting to the mar."

Ruby Miller of Chicago contributed this information on her late husband's Hawkins line. Her records on Robert and Nancy are on their children and vary a little from "Our Kin". Mrs. Miller writes":

"The first born was a little girl who died in infancy. Then they had a son John F., (probably Fourqueran). He was b. Apr. 24, 1797 and d. Sept. 26, 1887. Lucinda Campbell who was b. Nov. 21, 1806 died on Mar. 8, 1880 and she was his wife and they were mar. June 15, 1824. Lucinda was the child of Lewis Campbell and Susanna Monroe and they used to live in Amherst, CO., VA.

#### DRURY HAYWOOD HAWKINS

Hawkins Heritage member Betty Christopher sends some of her ancestry from the Drury Haywood Hawkins and Mary Evaline Burton line. Drury was Betty's great great grandfather.

Their children were: Drury Haywood (1856-1935); James Henry; Willis (1861-); Tilford Austin (1862-1933), who married Luvinie Davis Johnson (d1882 in childbirth). They were Betty's great grandparents; Samuel (1868-); Martha (b1865 and m. Pleasant Davis, b/o Luvinie); Permelia m. Jackson; Mary (b1869); Louisa (b1855); Nancy (b1859); N.E. (fem. b1860); and Ephriam.

Betty says that Drury and Mary Evaline Hawkins not only raised their own large family, but provided a home for many oprphaned children, as many as "twenty children other than their own, lived with them for a time."

Tilford Austin and Luvinie Johnson had Oscar, Betty Christopher's grandfather; Ada Myrtle (1892-1975) who m. Elijah Baxter Hogan Jones; and twins Ora m. George James, and Oris, who died at birth. Tilford's second wife was Minnie Ford. Their daughter was Iola, who m. Arlie Crisp in OK.

Oscar Hawkins, son of Tilford and Luvinie, was born in 1888 in Pocohontas, AR., and died in 1961 in Garvin CO, OK. His first wife was Hazel Flowers and second was Maude Belle Wilkerson.

#### JAMES TILFORD HAWKINS

James was born in TN in 1820 and was brother of Drury Haywood Hawkins. Father was Isaac Hawkins and Mother was Elizabeth Jane Burton, b1829. Their following children were born in Pitman, Randolph CO, AR: Wm. Henry b1846; Willis B.; James Isaac; Samuel A.; Eliz. Jane; Wesley H.; John R.; Thomas S.; Drewry Farley (1864-1942, d. McAlester, OK. He married martha Graham, b. Poyner, MO.; and Rebecca Ann.

Betty's gggg grandparents were Mary Farley and John Burton, Jr. She has much information on the Farley line, dating to William De Falaise (France), who came to England with William the Conqueror. Surnames included are Hastings, Allen, Sefton, Cocke ("current spelling is Cox"), and Cochran. The first Farley of her line in America was Thomas, who lived in VA in 1623, and married Lady Jane Sefton.

# SOME QUAKER HAWKINS FAMILIES

Early Hawkinses are noted in Pa. soon after William Penn arrived. They settled in Chester Co., and Hinshaw, in his <u>Quaker Records</u> has some Hawkinses mentioned in Vol. II, for Pa.

Falls Monthly Meeting notes a William Hawkins who married Dorothy Enos at Burlington MM, on September 7, 1680. A "effrey Hawkins, born in England, married Dorothy Matlock, and had seven children. Some researchers think that one of their sons, John James Hawkins who married Mary Elliott in 1705, and died in Bucks Co., Pa. in 1755, were the parents of James Hawkins, who moved to Virginia, and then South Carolina, and who seems to be the ancestor of the Hawkins families who migrated to Ohio and Indiana in the early 1800's.

There have been several family histories written about members of this family and their descendants.

Carl H. Hawkins in his newsletter shows this family as his ancestors. He notes several earlier Hawkinses as his line, through tradition.

Kathleen has some information from him in the newsletter in Issue one.

I used Hinshaw, and some of the Hawkins family histories, and manuscript notes from Edward Claypoole to work up this family, as it connected with Cooks and settled in Indiana.

Many of the Quaker families had moved to both North and South Carolina in the 1700's. When the new Northwest Territory opened up, almost the entire group left the Carolinas and went to southwestern Ohio, as they wanted to live where slavery was not legal. The Friends had begun to oppose slavery.

James Hawkins and wife Martha Hallowell, married at Abington MM., Montgomery Co., Pa., They left there in 1757 and lived for a while in Loudon Co., Va. Some of their children were noted at Bush River Monthly Meeting by 1767. James died in Union Co. S. C. in 1793. Most of his children and their families moved to Ohio about 1805 to 1810.

His son, John was noted as living in Indiana territory by 1808, just west of what is now Richmond. Another son, Amos also moved to this same community in Indiana. The son, Nathan who married Ann Cook, moved to Butler Co., Ohio, and died there in 1805.

One of James and Martha (Hallowell) Hawkins' sons-James married Sarah Wilson., in Chester Co., Pa. He died in South Carolina. This Wilson family was the subject of one of the HH articles Have made a chart for that Wilson family as three Wilsons married Hawkinses, and Mrs. John Wilson was Dinah Cook.

Jehu Wilson and Sarah Hawkins were married at Cane Creek, S. C. in 1790. Sarah was the daughter, Isaac and Margaret Hawkins. (Isaac, a son of James and Martha)

Phebe Wilson married Amos Hawkins at Cane Creek MM., S. C. in 1791. This family also came to Ohio. Amos was a son of Isaac and Margaret Hawkins, brother of Sarah.

#### ISAAC HAWKINS OF VAN BUREN, ARKANSAS

Isaac Hawkins, born 1809\*, at Hawkinstown, Shenandoah County, Virginia; died 1858, in Van Buren, Arkansas; married August 1838, at Palmyra, Marion County, Missouri, Susan Margaret Wasson. Isaac and Susan Hawkins removed from Marion County, Missouri, to Van Buren, Arkansas, where Isaac was employed as a steamboat clerk for a steamboat company in which Isaac's brother, Philip Hawkins (1798-1870) and Isaac's uncle, steamboat Captain Philip Pennywitt, Jr., had substantial financial interests.

Isaac's father, William Hawkins, born c 1774, at Hawkinstown, Shenandoah County, Virginia; son of Joseph and Rebecca (FUNK) Hawkins; married in Shenandoah County, Virginia, Lydia Pennywitt. William's brother, John Hawkins, born c 1772, married Mary Ann Pennywitt. Lydia and Mary Ann were daughters of Philip Pennywitt, Sr., and his first wife Mary Moore. Philip Pennywitt, Sr., married second Nelly Dillen and had a son Philip Pennywitt, Jr., who was born in Shenandoah County, Virginia, in 1793; died in Arkansas, in 1868. Captain Pennywitt (1793-1868) was a half-brother to Lydia and Mary Ann Hawkins.

On 17 Sep 1812, John Hawkins and wife Mary Ann and William Hawkins and wife Lydia sold their land at Hawkinstown to an adjoining landowner, Israel Allen (Deed Book T, pages 259 and 262) and removed to Sugar Creek Township, Green County, Ohio. From there William Hawkins removed to Palmyra, Marion County, Missouri, where William died in the 1830's. see HISTORY OF GREEN COUNTY, OHIO, by George F. Robinson, page 314.

In Xenia, Ohio, Land Records, Volume 16, page 438, dated 14 March 1831, the legal heirs of William Hawkins, deceased, of the County of Marion and State of Missouri are listed as: Mary Hawk, wife of Devolt Hawk, George Hawkins, Joseph Hawkins and Isaac Hawkins.

That Philip Hawkins (1798-1870) was also a son of William Hawkins and a brother of Mary Hawk, George Hawkins, Joseph Hawkins and Isaac Hawkins is evidenced by the Hawkins History compiled 25 Apr 1952 by James E. Hawkins (born 1 May 1895) of Spokane, Washington. Mr. James E. Hawkins, on page 17 of his report quotes from Philip Hawkin's Journal in 1838:

"Brother Isaac and his bride Susan have located here. He has special training which will enable him to take charge of

the office of our steamboat operations. We have needed a man of responsibility for some time and Isaac should grow with us."

And, on page 18, Mr. James E. Hawkins again quotes from the Philip Hawkins records in 1848:

"Our brother Joe has arrived from Virginia. He has never married. He has opened a wagon sales and repair shop and should prosper in that business."

These two quotations from the Philip Hawkins Journal identifies Philip Hawkins as a son of William and Lydia Pennywitt Hawkins and a brother to George, Joseph, Isaac and Mary Hawkins.

Long before steamboating had really begun on the Mississippi River, Philip Pennywitt, Jr., engaged in navigating the western waters between Cincinnati and New Orleans on keel boats. To overcome the arduous task of cordelling the heavily laden keel boats upstream, Philip Pennywitt, at the young age of 25, in 1818, built at Cincinnati, Ohio, the steamboat CINCINNATI of which Philip Pennywitt, Jr., was owner and captain. Over the years Captain Pennywitt was captain of a number of steamboats among which were the CINCINNATI, the WAVERLY, the ARKANSAS, the NEOSHO, and was joint owner of the steamboat, THE 35TH PARALLEL and other steamboats. To handle the business affairs of his steamboat enterprises, Captain Pennywitt hired his nephew Isaac Hawkins.

In his will, written on 19 Oct 1865, and recorded in Pulaski County, Arkansas, Probate No. 433, Philip Pennywitt left to "James Dibrill Hawkins, son of my Nephew Isaac Hawkins deceased," a 520 acre farm in Crawford County, Arkansas, provided however, that the said James Dibrill Hawkins provide for the support of his youngest brother and sister Harry W. Hawkins and Hellena W. Hawkins until they become 21 years of age.

Captain Pennywitt's will further provides: "I give and bequeath unto Mrs. Susan Hawkins Widow of my nephew Isaac Hawkins the house and lot situated in Knoxes addition to the Town of Van Buren in which she resided on the 8th day of May A. D. 1861." And, provided that Mrs. Mary Hawk of the Town of Van Buren be paid an annuity or sum of one hundred dollars per annum during her natural life to be paid to her each year in equal semi-annual payments.

The 1860 Census for the City of Van Buren, Crawford County, Arkansas, shows Mary Hawk (Houck), born 1808, the sister of Isaac Hawkins was living on 15 June 1860, in dwelling Number 117 next door to Isaac's widow, Susan M. Hawkins, in dwelling Number 116.

The family of Isaac and Susan M. Hawkins as recorded in the City of Van Buren, 1850, 1860 and 1870 Census of Crawford County, Arkansas, is as follows:

THE GORDSPEED'S HISTORY OF N. W. ARK, 1889, on page 1153, has the following about Isaac Hawkins:

"James D. Hawkins, sheriff, is a native of this county, and was born September 1, 1843. His father, Isaac was born in Shenandoah County, Va., and was for many years a steamboat clerk. When as a young man he came to Van Buren, and he married Susan M. Wasson, at Palmyra Mo., where she was born.\* For some time he served as constable of Van Buren. He died in 1858, and his wife in 1881. They had five children, of whom four are living: James D., Josephine (wife of G. W. Wines), Harry and Holdena White."

Isaac's daughter, Josephine, and her husband George W. Wines are listed on 17 June 1880, in the 1880 Census of Crawford County, Arkansas as:

William Weaver, the father of this family was born in Virginia but all his children in Ohio. Abram as he's called in this census has Virginia listed as his birthplace also. In fact, Abram (or Abraham) may've been acquainted with some of William Weaver's Madison Co. Virginia cousins. The 1880 Census has Ohio as the birthplace for Abraham. (Moble Twp. Auglaize Co. OH, Roll #993-end of roll, Vol. 3, E.D. 9, Sheet 21, Line 7.) The family seems to have moved from Darke Co. to mearby Auglaize Co. sometime after the birth of Thomas M. in 1875 ("male" in record.)

Some family historians claim that Abraham and Eliza had no offspring, but the proof that they did indeed have children is in the 1880 Ohio census for Auglaize Co., Moble Twp. plus the Darke Co. Ohio Birth Records, and in the marriage records for two of his children: Sarah C. and James Albert Hawkins found in the Index to Supplemental Record Marriage Transcripts, Adams Co. IN. prepared by the WPA of Indiana in 1938 which give parents' names.

Bessie Hawkins Evans said this uncle of hers used to preach that there was an "animal heaven" too--a comforting thought to many youngsters (adults too) who had lost a beloved pet, but one which caused some embarrassment among some of the family members who thought it sounded a bit untheological at best! But maybe he knew something the others didn't!

#### Pinkethman (Pink) Hawkins

Joanna Neilson sent the following biographical sketch of Pink Hawkins, from The Indian Territory, a book published about 1880. There was no page with publication date or other information.



PINK HAWKINS CREEK

Born in 1816, at Alabama, on the Tallapoosa River, he is the son of the once well known Sam Hawkins, who married Jane McIntosh, daughter to the great Creek Chief, General McIntosh. Sam Hawkins was captured the same day that his father-in-law was killed, and suffered martyrdom for the same cause. Sam's brother Ben was wounded, but escaped, afterwards moving to Texas and settling among the Cherokees in that State, by whom he was afterwards murdered, it is said, at the instigation, or at least with the knowledge of, Governor Sam Houston, the Texas liberator. It is but justice to remark, however, that there are no positive proofs implicating the great Texan in the death of Ben Hawkins, further than that Hawkins was a stumbling block in the way of Houston's designs, and his death would have removed the obstacle.

Pink Hawkins, the subject of our sketch, was sent for three months to school at the Creek agency, near Muskogee, after which he moved to within twenty miles of Nacogdoches, Texas, at the age of eighteen or twenty, marrying Miss Annie Pigeon, by whom he had one daughter. Mr. Hawkins had a large plantation in this part of the country, which he worked with negro labor, having over twenty slaves. The Mexican war was the means of ruining him, as the negroes made their escape across the lines, as the subject of our

sketch returned to the Creek Nation without a dollar, settling on the Canadian River, near Eufaula. In the same year he married an orphan girl named Aggie, by whom he later had five children, four of whom are living, John, Billy, Louisa, Michael and Rose. John is between forty-five and fifty years of age. Mr. Hawkins has a farm close to Deep Fork, eighteen miles from Okmulgee, and a small stock of cattle.

When the war broke out, he joined General Chilly McIntosh, and was at the Newtonia, Elk Creek and Red Fork fights, rising to the rank of lieutenant-colonel at the close of the war. The subject of our sketch served fourteen years in the House of Warriors, filling one unexpired term, that of Wacie Hargo. At the commencement of the new constitution he was second chief for four years, and was offered the nomination for first chief, but refused the honor, as well as that of supreme judge and other important offices, preferring to attend to his farming interests. Before and during the war Mr. Hawkins was Chief of the Hillubie Town, under the old constitution. Mr. Hawkins, though seventy-four years of age, is a fine specimen of his race, straight, broad-chested and in excellent health, in appearance not over sixty, and more energetic than the majority of men are at the age of sixty. He is a man of good understanding and unblemished honesty, and is greatly beloved by his people.

In a query letter in the August issue of  $\underline{\text{H.H.}}$ , Jean Meier (1425 Hillside Dr., Plano TX 75074) wrote concerning Thomas P. Hawkins. Since the initial "P" has limited given names, she considered Philemon, but had not found a connection. Well, there are some of our members who take such as a challenge. Joanna Neilson seems to be such a member, and suggests that another possibility would be Pinkethman.

I will quote from Joanna's letter: "I have some pages from Reginald A. Smith's book, Hawkins of Devon. In writing about the children of Matthew Hawkins and Sarah Pinkethman Hawkins in Charles Parish, York Co, VA, he notes 'Hawkins, Pinkeman, son of Matthew by Sarah, b. Feb. 27, 1728/9, bap. March 30, 1729, and then he comments 'Why would a mother name her son Pinkethman if it were not her family name? And the name continues thrugh the Hawkins and into the Harvey families.' I certainly agree with him, and wonder if the Pink Hawkins in the enclosed biography who was the son of Sam Hawkins who married Jane McIntosh, might be carrying this same Pinkethman name."

"According to information from Reginald Smith's book, there were two Hawkins cousins who married descendants of William Pinkethman, b. 1653, d 1712 York CO VA. One was Matthew Hawkins b ca 1700 and d 2-July-1734 York CO VA, who m. Sarah Pinkethman (dau. of Timothy Pinkethman and gr dau. of William Pinkethman). Pink Hawkins was a brother of Thomas Hawkins, and was b. Feb. 27, 1728/29, and bap. Mar. 30, 1729.

Dec 10, 1779 Boarding Samuel Hawkins \$40.00, Sarah Hawkins \$40.00, Elizabeth Hawkins her account against the estate \$44.26, Boarding Matthew, Thomas Hawkins \$80.00. Paid David Leach for teaching Stephen Hawkins \$7.00. (Joanna asks if these were Pinkethman's children, and also that some of the records were not originally copied by her, so she cannot verify all the dates.)

Joanna also sent a copy of Thomas Hawkins' will, Lunenburg CO VA, dated 14-Nov-1758. He lists wife Mary, sons Matthew and John, and dau. Sarah. He left to Matthew, the Plantation on which he (Thomas) lived, and a third of the plantation to Mary during her life. He left a plantation on Island Creek in NC, to his son John. He left slaves to them all, and 200 acres of land to his son John, on Sandy Creek. "Ex. my brother Pink (Pinkethman) and my wife Mary." Witnesses were Jos Dobson, Jos Rudd, Matthew Turner, Martha Jarrot, and Jacob Coldson. Sec: Jos Williams, Jos Trueman, Wil-liam Caldwell, and Jms. Easter or Easton Securties. Also Samuel Young, security. Martha Young, orphan of John Young dec'd made the choice of Pinkethman Hawkins to be her guardian.

Joanna Neilson told me a story and I think it is quite interesting. I think you will enjoy it also.

born c1695 in York CO, VA, and died in Lunenburg CO, VA, was married to Agness Eaton, daughter of William Eaton and Sarah Pinkethman Eaton (Sarah was b1674). A descendant was Joshua Hawkins who married Sarah Cook. They moved from Lunenburg CO, VA to Rutherford CO, NC, to Greenville CO, SC.

Joshua Hawkins b1725, also had a son, Pinkethman or Pinckney, according to Reginald Smith. So Joshua Hawkins of Greenville, SC, had a son, William Eaton Hawkins, b1751 in Lunenburg CO, VA, and a grandson named Ichabod Hawkins b1804, who married his first cousin, Mahala Hawkins. They had three deaf girls. The great grandfather of Joanna Neilson's husband was born in Warm Springs, NC in 1806 and was deaf from the age of three years. He was sent away and was well educated, and taught sign language. It was said that he taught sign language in school at Warm Springs. The Neilson family also owned a trader's stage that went from TN to Warm Springs to Greenville, SC, so he would have been aware of the deaf girls in Greenville, and would also have been of the age to have taught them. Joanna commented that one of our issues mentioned a boy who the family saw talk with his hands. Joanna says "this is speculation," but she plans to check for a record of Philip Hale Neilson's students. Thanks for sharing, Joanna, and let us know what you find out! - OHA

Dear Olyve,

I just wanted to let you know I had some really positive response to my query in the Issue 15, April 1992 edition of Hawkins Heritage. First from Kathryn Gillaspie. We thought the THOMAS P. HAWKINS in her line was mine. He was not, but she sent me a page from a S.C. book showing the estate of PINKETHAM HAWKINS in Abbeville, S.C. All of the names in my query with the exception of ABIMALEK, were shown in the settlement. The inventory did not say they were his wife and children, but it paid ELIZABETH HAWKINS her share of the estate, and I know she was his wife because I found a Deed where PINKETHAM and his wife, ELIZABETH, sold land. I wrote to Abbeville and all they had was a Citation for an Administration Bond. It states that the first Citation was lost and the one dated 6 September 1782 was a replacement. I am going to write to the S.C. Archives to see if they have the inventory and other returns on the estate.

Within two weeks of learning about PINKETHAM I traced him <a href="back">back</a> from Abbeville to Johnston County, N.C., to Granville County, N.C., to Lunenburg, VA. Then I got a wonderful letter from Joanna Neilson! She had information that PINKETHAM was born in Charles Parish, York County, VA to MATTHEW and SARAH HAWKINS 17 February 1728/29. I went to the Dallas Library and looked at the Charles Parish records and found birth records of PINKETHAM and his brothers and sisters and probably his cousins. Joanna says PINKETHAM's mother was SARAH PINKETHAM and that she was the daughter of TIMOTHY PINKETHAM and grand-daughter of WILLIAM PINKETHAM. I have not found proof of this, but Joanna is going to send me a copy of WILLIAM PINKETHAM's Will, and I am going to keep digging until I fit the pieces together. Olyve, the chart you sent on MICHAEL HAWKINS is helping me, too. Joanna says MICHAEL and my MATTHEW were cousins or brothers.

I have been trying to determine the Indian heritage in my family. I am enclosing a copy of a photo of my great-grandmother, ANN HAZLETINE BRASHER DUPRIEST. She was the grand-daughter of THOMAS P. and LUCY COLDERT HAWKINS. It's obvious that she had Indian blood, but I cannot find the Indian ancestor. As I mentioned in my query, THOMAS's brother, STEPHEN, married a half blood Creek, and their son, SAMUEL, married JANE McINTOSH, daughter of CHIEF WILLIAM McINTOSH, making SAMUEL and JANE's son, PINK, almost full blood. I am enclosing a biography of PINK, including a photo of him that Joanna sent me. The story of the murders of SAMUEL HANKINS and his father-in-law, CHIEF McINTOSH, including the pitiful letters from their wives, has been published in several books, but very little has been written about SAMUEL's father, STEPHEN. In the U.S. House of Representatives's Report #98 - 1825, he stated he was on his way from Fort Jackson to his residence at Chelokons in the Indian Nation when he was stopped by eight or ten hostile Indians headed by JOHN RILEY, a half breed.RILEY told him they were sent by APOTHLEY-YOHOLA, a Tuckabatchee Chief, to take all the property belonging to the HAWKINS and McINTOSHES and to

carry it back to Tuckabatchee. They took all the property he had with him except the horses he and his wife were riding, which they took later. The property they took was, (remember, he was an Indian trader) two negro boys, 100 yards of homespun, two sacks of salt, and a number of other items. They should not, he told them, take his property as he had nothing to do with the treaty. RILEY told him that he was ordered by the Indian Agent Crowell and the Chiefs to do it. Fearing for his life, as they had killed his son, SAMUEL, he and all his family "now live at Fort Jackson". He signed his statement June 21, 1825.

Another story that may or may not be true, is that SAMUEL HAWKINS' brother, BENJAMIN, who was wounded by the hostile Indians but escaped, came to Texas with DAVY CROCKETT. I do know that DAVY CROCKETT's mother was REBECCA HAWKINS, so perhaps this was true.

Thank you very much to those who took time to help me, and if anyone else has any information that might help me, or, as Joanna did, if you would like to speculate on my line, please write to me.
