Gale to Vicars

Registered the 25 day of June 1732 at twenty minutes after 10 O'Clock in the aforenoon.

To the Registrar appointed for Registering Deeds Dublin

A Memorial of Deeds of Lease and Release bearing dates the Twelfth and Thirteenth days of April One Thousand Seven Hundred and Thirty Two. The lease made between Samuel Gale of Crottentegle in the Queens County gentleman on the one part and William Vicars of Granstowne in the said County Esq. of the other part and the Release being an indenture ? for life and made between the said Samuel Gale of the first part, the said William Vicars of the second part, Anthony Gale, son and heir apparent of the said family Gale of the third part and Mary Vicars, eldest daughter of the said William Vicars of the fourth part. The Release reciting a marriage intended then to be had and solemnized between the said Anthony Gale and Mary Vicars. By which release, the said Samuel Gale for the consideration therein mentioned did grant and release and confirm unto the said William Vicars all those the lands of Crottentegle, Ferraghbane and Cool Grane? ? in the Barony of Slivemarge and Queens County with their appurtenances to hold the said William Vicars and his heirs to and for the ? ? Trusts. Intent (?) and purposes (?) in the said Deed of Release particularly mentioned which is Deed of Lease and Release on this memorial are witnessed (?) by Robert Vicars of Granstowne in the Queens County Gentleman, Oliver Grace of Skehanagh (?) in the said County Gentleman and Richard Mack Dorvall of Crottentegle in the said County Yeoman.

Signed and sealed in the presence of all. The above words (situate in the Barony of Slivemarge and Queens County) being first intended between the Tenth and Eleven lines of the above Memorial. Robert Vicars, Oliver Grace, Richard Mack Dorvall.

The above mentioned Richard Mack Dorvall maketh oath that he saw the above named Samuel Gale only seal and execute the above named mentioned Lease and also saw the said Samuel Gale and the above named William Vicars, Anthony Gale and Mary Vicars only seal and execute the above mentioned Release of which said Deed of Lease and Release the above writing is a Memorial and also saw the said Samuel Gale only sign and seal the said Memorial and that this deed (?) is a supporting (?) witness to the said Lease, Release and Memorial and delivered the forms to Mr. (?) William Barry, Deputy Registrar on the 25 Day of June 1732 at near half an hour after 10 O'Clock in the aforenoon.
