I Duncan McVicker, of the Borough of Schellsburg, in the county of Bedford and state of Pennsylvania, do make and publish this my last will and testament, in manner and form following: to wit.

1st It is my will that all my just debts and funeral expenses be fully paid as soon as can be conviently can be after my death.

2nd As for my son George A. McVicker, he has received his full share and has Acknowledged to be fully satisfied with what I have sent him.

3rd I give and bequeath to my Grand-son Winter D. Hamaker, one thousand dollars and I give unto my Grand-daughter, one thousand dollars.

4th I give unto my daughter, Sarah J. Hamaker the balance of all my real and personal property after all funeral expenses paid and I have made two deeds by S.J. Hamaker which is to be handed over to her as her property and I do not wish any appraisement to be made of my property or valuation. I constitute and appoint Sarah J.Hamaker, my daughter, to be my executor of this my last will and testament, hereby revoking all other wills. February 15, A.D. 1879 one thousand, eight-hundred and seventy nine.
