RASH (RAICHE/RÉCHE/REICHE).*

Two brothers, sons of Pierre⁰ and Magdeleine (Fleurant) Rash of Canada East, settled in Passumpsic and Joes Brook districts of Barnet about 1855 and 1863.

Of whom no one seems to know anything, is a 1873[43?] Westmore, Vt. town clerk office record that reads: "died this year: Peter Rash (son of Jack & Rhoda)". The evidence still existent points to this being Pierre/Peter⁰ Rash (spelled Reiche/Rêche/Raiche in his native Canada), patriarch of the Rash families who settled in Barnet; and great-great-grandson of Louis Pinard-dela-Rochelle, Lord's attorney and master surgeon who had first come to Quebec from France sometime before Sept. 8, 1647 [René Jetté, Dictionnaire Généalogique des Familles du Québec, p.918].

The grandfather of Peter,⁰ Jean-Baptiste Pinard-Beauchemin-Reiche, adopted the family's surname of "Reiche" from François Reiche of Languedoc, France. François was brother-in-law to Peter⁰'s father and son-in-law of his great-great-grandfather Louis Pinard-de-la-Rochelle.

Peter⁰ was b. ab. 1790/1800; m. Nicolet, Que. Aug. 6, 1822 his second cousin Madeleine (b. July 7, 1795 [cc]) dau. Antoine and Magdeleine (Laspron) Fleurant-Pinard [mc]; they had at least twelve children. Of the others: Marie-Magdeleine m. Alexandre Boisvert [Greenwood] and is bur. in Stanstead; Peter Jr. m. Julia A. Carpenter and settled in Orleans County where he has a numerous progeny; Emile d. young; Elise m. Amable Lafond; Louise m. Theodore Lefevre; Rose deLima, destiny unk; Grégoire [George] m. Anastasie Bélouin and lived for a time in Bradford; Abraham Odilon, destiny unk; Marie-Hélenè, destiny unk; and Emilie, destiny unk.

Jan. 21, 1870; d. while living with her sister Clara Lenton above Passumpsic [int w/Millicent Lenton] May 7, 1902 of TB [gs/dc]) dau. William and Mary (Baird[ej]) Logan [Hattie dc]. He d. St. Johnsbury Hosp. March 26, 1937 Æ 76y4m8d of Arteriosclerosis/Cerebral Thrombosis, bur. Passumpsic Cem. [dc]. Mason, plasterer, and bridge builder [St.J/Barnet Directories 1904-25].

VII. John François,² ["John" {1870/80 census / "François" {cc}] twin of Sophia b. Dec. 28, 1861; bapt. Sacré-Cœur de Jesus, Stanstead Jan. 1, 1862 as "François" [cc]. Died between 1902 and 1915 [bro.Albert and sis-in-law Hattie OBITs].

VIII. Sophia,² twin of John and bapt. with him [cc]; m. Ste. Monique, Nicolet, Comté Nicolet, Que. Oct. 25, 1895 Möise son of Grégoire and Esther (Bellefeuille) Pinard [mr] [her marriage record lists her mother as "Marg. Gadeli"].

X. George Frances,² [cc] b. Stanstead Oct. 10, 1866; bapt. Mission de Sacré-Cœur de Jesus, Stanstead Nov. 11, 1866 [cc] [1870 census says, "age 2"]; d. between 1870 & 1880 censuses.

Sacré-Cœur de Jesus, Stanstead Feb. 1, 1852 [cc]; immigrant 1863/69/70; not naturalized [census records]; farm laborer on Milo Lawrence [later Daney Alger] farm, Passumpsic [1880 census]; m. Barnet Parsonage [Cal.Rec.710/1884] July 3, 1884 Lena Almira [BVRmr] (b. Calais [mr] Sept. 1867 [1900 census] and residing in Barnet [Cal.Rec.7/10/1884]) dau. George and Julia (Bigelow) Emmons [Lena BVRmr]. He d. at home on Joe's Brook Nov. 16, 1915 [OBIT] of acute indigestion and cerebral hemorrhage; bur. St Johnsbury Nov. 19 [dc]. The family lived with his uncle Frank's widow Matilda (Paquin) Rash on what is now called Brook Hill Road, in the house owned by L. Heath in 1875; buildings burned; lot occupied by trailer in 1998.

Richard enlisted for WWI Feb. 21, 1909 at Boston; stationed USS FREDERICK April 6-24, 1917; Reserve Station, Manchester, N. H. when m. May 24; when disch. he reenl. May 26, 1917 at Boston; stationed there to Dec. 17 when he reported to USS BRIDGEPORT where he served to Dec. 28 when "Received for Shipment" at Philadelphia; shipped Jan. 13, 1918 to Naval Air Station Pauillac, France and served to Feb. 21; Naval Air Station Gujon, France to Apr. 21; Naval Air Station Paris to Apr. 26; Naval Forces London to July 30; Northern Group, Squadron 1 to Nov. 11; transferred to inactive duty at Boston June 23, 1919; ranks: GM1 208 days, GMC 345 days [Navy Records] / [Roster of Vt Volunteers]. Ch.: Richard Miles,⁴ b. Waterford Apr. 21, 1918 [bc]; d. there same day of compression of cord in utero [de].

III. Willie R.,³ b. March 1892 [1900 census]. He had a missing palate which caused a speech impediment for which many thought him less intelligent than he was—which he used to his advantage in his 20' s as a horse trader [and occasional horse thief]. Neighborhood horses would occasionally escape in the night from their pasture or stall and disappear without a sound or leaving tracks. Willie was eventually caught leading a horse from its barn, feet wrapped in burlap bags to muffle sounds and mask any tracks. He would remove a horse from barn or pasture, go to Eden by night, and on Burlington way the next day and sell it [old time neighborhood story]. His destiny is unk.

Dame des Victories, St. Johnsbury the next day as "Julia Catherine Jessie Gadélie" [cc]; d. St.J. Hosp. Feb. 6, 1958 of cerebral thrombosis [dc]) dau. John-Baptist Martin¹ Gadley and Julia¹ Emmons.

John-Baptiste Martin¹ Gadley was b. Wickham, Comté Drummond, Que. July 19, 1828 [dc]; d. Barnet Aug. 20, 1917 Æ89y1m1d of chronic intestinal kidney disease; bur. Mt. Calvary Cem., St. Johnsbury [dc/gs]. A brother of Nelson's mother, Catherinè Gadley, he served as Corporal, Co. G., 15th Vt. Infantry duringt the Civil War [gs]. Jesse's grgrson maintains his 1860's rifle in good working order, displaying it over the mantle in his post-and-beam home [visit]. Julia¹ (Emmons) Gadley was b. Drummondville, Comté Drummond, Que. Aug. 24, 1837 [dc]; d. Barnet March 13, 1918 Æ81 from a stroke; bur. with husband [dc/gs].

Nelson² d. Memorial Hosp., Brattleboro, Vt. May 8, 1921 after being thrown by a load of timbers from the trestle he was repairing at the washout on the Boston & Maine Railroad near Mount Hermon, East Northfield, Mass. The locomotive had backed out onto the trestle and struck the car too hard, throwing down the load of timbers, and knocking Nelson from the trestle; he landed on a cross timber near the bottom and was thought dead; two workmen climbed down to recover the body; finding him still alive, he was brought up and placed in the rear car, dying two days later [son Walter's eyewitness account]. Bur. with Jesse² at Mt. Calvary Cem. [gs].

Jesse² m. 2nd St. Johnsbury Apr. 30, 1923 another cousin, Frank William Gadley (b. Hatley, Que. [mc] Nov. 27, 1870 [Chh.mc]; res. Cookshire, Que.; R. R. section foreman) son of [Antoine Benoît] Benjamin and Elizabeth (Vallée) Gadley [mc] and widower of Anne Stacy (b. Concord, Vt. [Frank.Jr 1894 bc]). His father, Ben, was a brother of both Jesse's father and Nelson's mother and was bur. 1909 at St. Suzanne de Stanhope Cem. [p. 230 of *Three Towns*, LSC Lib].

Cathédrale Notre Dame des Victories, St. Johnsbury the same day with the name: "Joseph Edmundum Walter Raiche" [cc]; bridge carpenter and foundryman; res. Passumpsic; m. Cathédrale Notre Dame des Victories, St. Johnsbury Aug. 3, 1925 Ruby Plum⁶ Somers [mc] (b. St. Johnsbury July 6, 1907; d. Hanover, N. H. Hosp. March 21, 1989) dau. Peerez Newell⁵ and Grace Laura⁵ (Bovee) Somers, q. v. (pp. 348 & 614). Walter d. St. Johnsbury Convel. Ctr. Jan. 31, 1985 of cardiac arrest while resting in a chair after being exercised by walking in a corridor; both bur. Danville Green. They lived in Passumpsic Village and raised three children there. After adoption of 4th ch. they rem. to Danville, and later, St. Johnsbury.
