- i. George Walden Meyers b. 24 September 1765; bapt. as Johan George Waldemeyer on 13 October 1765 at St. Paul's Luth. Ch. of Wurtemberg, Rhinebeck, Dutchess Co., NY. His grandparents, Joh. Georg and Margretha Waldemeyer were sponsors.
- d. after 1820 and before 30 August 1839, when his son, Peter, sold some of his land in Lot 7, Conc. 1, Sidney, as "heir-at-law of George W. Meyers".
- m. 5 May 1789 at St. Paul's Ch., Fredericksburgh, Lennox and Addington Co., Ontario, Canada, Alida Van Alstine, eldest (and only surviving) daughter of Peter Van Alstine, another Loyalist, who had settled in Adolphustown. George was of 8th Twp. (Sidney) and Alida was of 4th Twp., (Adolphustown). Witnesses were Anne Williams, Tobias Walden Meyers, and Alex. Van Alstine.

George was a teen-ager when his father became active with the Loyalists. He was not given a pass by the Board of Commissioners in Albany when Polly requested one for her family to join John behind the British lines in New York City, because he was considered old enough to do work on the farm. His father later succeeded in joining George with the family.

By the time the family was settled in Hastings Co., Ontario, George was old enough to receive land in his own right. He and his brother, Tobias, shared 300 acres in Lot 7, Conc. 1, Sidney. George also owned 200 acres in Lot 29, Conc. 5, Sidney, and his wife, Alida, owned 200 acres in Lot 30 adjoining his. George also owned 400 acres in Lots 11 and 12, Conc. 4, Rawdon. He requested land for a mill site in the town of Murray, but it was rejected. (Land Board Cert. 30/5, Sidney, refers to one of his parcels of land.)

George later became operator and miller of the Stone Mills owned by his father-in-law, Peter Van Alstine, at Lake-on-the-Mountain, Prince Edward Co., probably shortly before 1800. In 1801 he was on the census for Adolphustown.

In 1798 preparations were being made for a local militia to protect their homes if necessary. George and his brother, Leonard, were made captains. Capt. John Walden Meyers was placed in command of the local militia at Meyers Creek. The younger son, Jacob, was an ensign. He later became a captain, too. John continued in command until 1812 (the beginning of the war) when he was succeeded by his son, George, who later became a Major.

George was active in local affairs just as his father was. He was also on the agricultural committee that was formed in 1820 to promote a fair in Belleville.

VI. Elly W. Meyers was b. 20 June 1800 at Adolphustown, Lennox
and Addington Co., Ontario, Canada; bapt. 29 June 1800 at
McDowall Memorial Ch., Sandhurst/Bath, Fredericksburgh Twp.,
Lennox and Addington Co., by Rev. Robert McDowall, as Alley
Miers. (Presby. Recs.). Many variations have been used for
her first name--Allie/Eliza/Ella/Ellen/and even Alice. She
d. 5 November 1874 in Camden Twp., Kent Co., Ontario, Can.
m. 15 December 1818 by Rev. Robert McDowall (Presby. Recs.)
to George Westfall bapt. as Jeurie Westfall 27 May 1792
at Rhinebeck Ref. Ch.³, Dutchess Co.,¹NY. He was the son
of Abraham⁴ Gysbert³ Simon² Juriaen¹ Westfall/Westvael.
He d. 25 December 1868 in Camden Twp., Kent Co., Ontario,
Can., near Thamesville. (He 1851-61 and she 1851-71 Census)
In the 1871 and 1881 censuses their religion is given as
"Christian". This is not a general term, but a specific
religion.

Elly apparently received land because of her father's
military service. (O.C. 6 February 1822) One certifi-
cate identifies the land as E $\frac{1}{2}$ of Lots 7 and 8 in Conc.
2, Orillia, but a line was drawn through. That certi-
ficate was dated 7 April 1825, and there was proof dated
10 August 1830 that the settlement duty had been per-
formed. A form giving the location date as 21 August
1828 had "Cancelled" written across it, but the date of
cancellation wasn't legible.

A note dated 27 March 1832 was a testimony by John
Smyth that Elly Westfall of Rawdon was living "last
summer . . . and I believe she is now alive".

A form No. 11603, dated 30 September 1835, still lists
Elly's grants as E $\frac{1}{2}$ of Lots No. 7 and 8 in Conc. 2,
Orillia, containing 200 acres, but neither Elly nor
George appear on those land records as owning the land
at any time.

On 30 July 1839 George Westfall, called of "Rodden",

appointed William Mills, an attorney, to deliver a Patent for 200 acres of land to which he was entitled as husband of Elley Westfall, dau. of George W. Meyers, a United Empire Loyalist. Another note in the papers, dated 28 March 1839, says "Lot # 18, 10th Conc., Belmont". Belmont Twp. was in Peterborough Co., next to Hastings Co. Peterborough Co. records show that Elley Westfall received a Patent from the Crown for this land 3 July 1844, all 200 acres. There is no record of them selling the land, and there are no other familiar names on the land transactions. The next entry is a B. & S. for Adam H. Meyers selling the land 12 April 1855. (I believe he is not related to John's family.) I doubt that George and Elley ever settled on this land, as he appears on a tax list in Norwich, Oxford Co., Ontario, in 1841, and their last child was born there 29 January 1843.

Elly's father had deeded land to her as "Ally Westfall" 18 March 1824- Lots 11 and 12 in Conc. 4, Rawdon. George and Elly sold this land 24 June 1840, probably just before they moved to Oxford Co.

George and Elly must have moved frequently. They were apparently of Sidney Twp., Hastings Co., Ontario, early in their marriage, then in Rawdon Twp. before moving to Oxford Co. After living in Oxford Co. a few years, they must have moved to Moore Twp., Lambton Co., Ontario, where they were living when Elley purchased land in Clay Twp., St. Clair Co., Michigan, as a resident of Moore Twp., on 13 August 1846. They remained there only about 10 years when they bought land 2 August 1858 in Lot 12, Conc. A, in the front range of Camden Twp., Kent Co., Ontario. They remained there until their deaths. The land contained a "2 storey brick house" on the north side of the London Chatham Road. It was these land records in Kent Co. that proved my relationship. One record of quit-claims to their property named all eight of their twelve children who were still living, including my great-great-grandmother, Catherine, widow of Lewis Green, of Newaygo Co., Michigan. George Westfall was called "yeoman".
