Additions and Corrections to V.I, p.9
(See V. I for further information.)

- i. George Walden Meyers d. bet. 1827 (when his name was on a land record in Sidney Twp., Hastings Co., Ont.) and 1 January 1837 (when his dau.-in-law, Ann Meyers, released her dower rights to the land in Lots 5 & 6, North Marysburgh. P.W. Meyers was listed on a bill of sale for the same property 2 February 1837. On 20 March 1838 Peter W. Meyers is called "son and heir-at-law of George".

George was apparently connected with the Vanalstine mills, which belonged to his father-in-law, Peter Vanalstine, from the time of Peter's death in 1800 to as late as 27 June 1826 when his nephew, Allen Vanalstine, mortgaged all his right in the property to George W. Meyers. Allen apparently sold his share to his mother, now Ursula McWhirter, on 16 June 1831. She sold to David Lake 21 December 1839.

Their efforts to sell the mills in 1811 apparently didn't succeed, as George leased the mills from the execs. of Peter's estate on 27 June 1816. Did George live most of his life in the area of the mills, either at Adolphustown (where he was on a census in 1801) or in North Marysburgh (where the mills were located)? Or did he just have an interest in the mills and allow someone else to run them?

George sold land in Hastings Co. to Peter Davey (prob. his step-brother) 17 March 1826. Peter sold it to Sophia Davey (prob. his mother (who apparently took back the name Davey after the death of her husband, John Walden Meyers) on 18 November 1835. As Sophia Davey, she willed the land to her dau., Sophia Billings, on 22 February 1836.
