vii. Anna Walden Meyers was bapt. 10 December 1775 as Annatje Waltmyer at Cocksackie Dutch Ref. Ch. in then Albany Co., now Greene Co., NY. d. 10 December 1844, age 67y.10mo.14da. (g.s.). (Her age at d. would make her b. date 29 January 1777, so her age at d. may be in error.) She was called Nancy on many land recs. and on her g.s. (Much info. on her family came from Douglas Crawford of Hillier, Ont.) m.(1) prob. bet. 1793-1797 (not 1806, as in V.I) Caleb Gilbert (not William Gilbert, as stated in V.I.) b. ; d. by 1811. (In 1811, when John Bleecker and John Meyers obtained the Crown Deed for Lot 11, Conc. 1, Rawdon, Meyers was called "assignee of Caleb Gilbert, dec.". Lot 30, Conc. 1, Sidney, was patented to Caleb Gilbert 31 December 1798. This was sold in 1811 by Samuel & Stephen Gilbert as "heirs-at-law" of Caleb.) (Nancy signed her name on a land rec. in 1793 as Nancy Meyers, but on 9 November 1797 she is called "Anna Meyers, alias Gilbert, wife of Caleb Gilbert, Esq.".)

m.(2) ca. 1811-1812 Thomas Jones, Sr. b. 23 February 1770 (from age at d.); d. 9 August 1837, age 67y.5mo.17da. (g.s.); will dated 11 November 1830; pro. 31 March 1838. (Rec. of will from "Wills & Adm. of Trenton", formerly part of Northumberland Co., but of Hastings Co. in the late 1800's- Film #0197863 at Family History Lib., Salt Lake City, UT) His will asked that his body be bur. in Ezekiel Lawrence's Burial Ground near Belleville. Memorial N2137 from Sidney Twp. Deed Bk. A reads "Thomas Jones, yeoman, and Nancy Jones, his wife, dau. of John Walden Meyers". (I will place all of Anna/Nancy's children 1st; then I will place the children of Thomas from his m.(1), as they will be of interest to Anna's desc.)

She wouldn't have been old enough to have adult children by 1811, so if Samuel and Stephen Gilbert, as heirs-at-law of Caleb in 1811, were his sons, they must have been from a m.(1) for Caleb.)

Annis is listed in her father's will as Annie Jones. I believe Nancy d. bet. 1861 & 1865 and her husband m.(2) her younger sister, Annis. Her children are with them in 1871, plus 2 more.)
