Family of Michael Waltermeyer, probably the 7th child and 4th son of George Waltermeyer, Sr., and his wife, Margaretha.

(Some sources have him older than Barbara, but I believe he belongs here.) I haven't found a rec. of Michael's b. or bapt., but he is ment. in his father's will.

b. ca. 1760 (from age at d.); d. 2 June 1813, age 53 (B.R. of son-in-law, Conrad Gaul); will dated 1 June 1813; pro. 20 July 1813 in Claverack, Columbia Co., NY. The real estate was to remain undivided until the youngest child became of age. (1790-1810 census)

m. ca. 1780? Sara/Sally Kranckheit b. ca. 1764; (HWW says 1761); d. 2 May 1837, age 72+ y. (Rec. at Christ Evang. Luth. Ch. of Ghent) (B.R. of Conrad Gaul gives d. date as 30 April 1837, age 71, so perhaps 2 May was the bur. date.) (1790-1810 census)

She was named exec. of Michael's estate with her sons, George M. & John.

Michael served in the 6th Rgt., Dutchess Co. Militia, in the Rev. War. In Land Bounty Rights, his name is spelled "Wattenmaer".

He is reported to have erected a tavern on the turnpike, which was still standing as a tenement in 1878. Michael was in possession of land in Little Nine Partners, previously owned by his father, at the time of his father's death.

The family is reported to have emigrated from Holland in 1781, purchasing 600 acres of anti-rent land for 12½¢ per acre. This would mean that Martin was b. in Holland.
