That the contents of the above obligation is such, that whereas, the above bounden Harry E. Morgan
has this day applied to the Clerk of the County Court of Greene County for a License authorizing the solemnization of the Rite of Matrimony between
the said Harry E. Morgan and Miss Lottie Mae Byrd.
Now, if the said parties applying for said License have a lawful right to the same, and if they shall faithfully carry into effect and comply
with the provisions thereof, and shall, within sixty days from the date hereof, return said License to the office of the Clerk of the County Court
