First, I give, divise and bequeath to my daughter Elizabeth Gresham, a negro woman named Mary and her child, July (which negro she has in her possession) together with their future increase to her, and the heirs of her body, and should she die leaving no heirs of her body, it is my will and desire that the above named negroes with their increase, should return to my estate, and be equally divided amongst all my children then living, to them and their heirs forever.

Item, I lend unto my beloved wife, Martha T. Fraser during her widowhood all of my estate both real and personal (except the property already devised to my daughter, Elizabeth Gresham) to be kept together for the purpose of pay? all my just debts and supporting her, and educating and supporting all my other nine children; to wit: Edwin Fraser, Martha T. Fraser, Frederick R. Fraser, Alexander Fraser, Robert B. Fraser, Mary Ann Fraser, Caroline Fraser, John W. Fraser, and Harriet M.S. Fraser, until they marry or arrive to lawful age, and then it is my will and desire that my beloved wife will advance to them so much of my estate as she can conveniently spare, so as to make it equal amongst them all, to them and their heirs forever.

Item, it is my will and desire that the rest and residue of my estate both real and personal be equally divided between Frederick R. Fraser, Alexander Fraser, Robert B. Fraser, Mary Ann Fraser, Caroline Fraser, John W. Fraser and Harriet M.S. Fraser, to them and their heirs forever.

Lastly, I do hereby nominate and appoint my son Edwin Fraser executor and my wife, Martha Fraser, Executrix to this my last will and testament. In witness whereof I have here unto set my hand and seal this fifth day of January, 1828

Will of Martha T. Fraser, 1855

I, Martha T. Fraser, of the County of Dinwiddie, and the State of Virginia, considering the uncertainty of human life, do make this to be my last will and testament, as follows, that is to say:

1st. I give to my son Edwin Fraser, the sum of Five Hundred Dollars in money.

2nd. I give to my daughter, Martha T. Rogers, the sum of Five Hundred dollars in money.

3rd. I give to my daughter, Caroline Thweatt:

one bureau, one wardrobe, one sofa, one sociable, two mahongany dining tables, one dozen cane seat chairs, one tea table, one curtain bed-stead and furniture, one trundle bedstead and furniture, china tableware, set of castors, brass kettle, one pair of long brass candlesticks, two oil carpets and two Turkey carpets, all my silver spoons, all my glassware and one set of best knives and forks, one rocking chair, my carriage and harness, one horse which she may select and the following slaves, viz: Sally, Moses, Julia, Jenny, Adolphus, Albert, Dick, Amy, Nancy, Isaiah, William and all their future increase, and one half the moneys I may have on had at the time of my death (after payment of the above mentioned legacies to Edwin Fraser and Martha T. Fraser) to her and her heirs forever.

4th. I give to my son, John W. Fraser, the following slaves, Viz: Charles, Anthony, Sukey, Almaira, Winney, Clarissa, Peter, Lucy, Thomas, Susan, Sarah Ann, with all their children, and with their future increase, two bed-steads and furniture, two dining tables, one clock, one dozen windsor chairs, three pairs and-irons, three pairs shovels & tongs, my threshing machine and fan mill and the balance of the monies I may have on hand at the time of my death (After the payment of the legacies to Edwin Fraser, Martha T. Rogers and Caroline Thweatt) to him and his heirs forever.

5th. I give to my grand-daughter, Harriet M. S. Fraser, one bed-stead and furniture and one bureau to her and her heirs forever.

6th. I hereby nominate and appoint my son, John W. Fraser, to be the executor of this my last will and testament, hereby revoking all other former wills made to me and it is my wish and desire, as I am not indebted, that the court will require no security of him. In witness of all the foregoing, I have hereunto set my hand and seal this 14th day of december 1855.

equally divided among his 10 children - - but, not their heirs. Therefore, the children of Betsy, Frederick, Alexander, Robert and Mary Ann are not mentioned. BUT, the ONE of the heirs of Frederick Fraser IS mentioned (grandaughter Harriet), BUT not his other heirs (ie: Thomas, Mary Jane and Frederica) This will was challanged by those unmentioned heirs in 1857 and 1862.

Dau. Betsy - not mentioned, nor any heirs Son Frederick - died 1846, Dau. Harriett mentioned in will. Son Alexander - not mentioned, nor any heirs Son Robert - died 1841, heir Robert B. Fraser, Jr. Not mentioned Dau Mary Ann - died 1838, heir George Alexander Whitmore not mentioned Dau Harriet - died 1828

Frederick Reese had two heirs, Martha Tatum Reese, who had married Alexander Fraser (Frazer, Frazier, Frasier) of Dinwiddie county, Virginia in 1803 and Hebert Reese. In the event that son Herbert Reese died without heirs (which he did), Herbert's portion of the estate would go to Martha's son, Frederick Reese Fraser.

To settle the debts of Frederick Reese, both heirs were required to split the debts. At the time of probate, a debtor (Martin Blake) stepped forward with a bill of \$273.20, and Martha duly paid her half (\$136.60), but Herbert allowed the Sheriff of Dinwiddie county to auction off one of Frederick Reese's slaves, a young woman named Eliza, to settle the his portion of the debt. Apparently, her "increase" (children) should have remained property of the original estate. So, after Herbert's death about 1850, Frederick R Fraser came forward to demand those children or their value. Of course, the purchaser of Eliza, Archer Bevill, thought he was buying her "increase" and did not think that Frederick R Fraser was due those children or their value, therefore he objected. Originally, the court dimissed Frederick R Fraser's case, but on appeal it was decided that Bevill was due to pay Fraser for the "increase" based on the original will. And that Bevill's own costs of maintaining said "increase" was more than satisfied by any work that they had performed for Bevill.
