Kings Mountain, Blackstock's Plantation, Cowpens and several skirmishes. After resigning his commission during 1781, he joined Gen. Sumter and once again became a lieutenant. A.A.497; N.A.859; N.A.246.

### **Bird, John** S10372

b. 1754, Duplin County, N. C.  
While residing in Camden District, he enlisted during June 1776 under Capt. John Graves and Cols. Robert Goodwyn and Kirkland. He was in the battles at Kettle Creek, Nassau Creek, Stono, Rocky Mount, Sumter's Defeat, the siege of Augusta, Eutaw Springs and many skirmishes. In addition, he was on the Florida Expedition. (Moved to Ga. and Ala.)

### **Bird, John**

He served in the militia under Col. Brandon after the fall of Charleston. A.A.497; X2761; C.S.

### **Bird, Nathan**

He served in the light dragoons under Capt. William Smith, Lt. Col. John Thomas, Jr. and Gen. Sumter. A.A.497-A; M474; C.S.

### **Bird, Robert**

He enlisted in the Third Regiment on 21 February 1777. During 1779, he became a sergeant under Capt. Felix Warley. N.A.853; N.A.246; S.C.H.&G., V, 144.

### **Bird, Samuel**

He served in the militia before and after the fall of Charleston in Roebuck's regiment. A.A.498; X3365; C.S.

### **Bird, William**

He served in the militia during 1782. A.A.499; A.A.977; N106; P11.

### **Bird, William**

He served under Cols. Roebuck and Brandon. A.A.497; A.A.499; X3664; C.S.

### **Bird, William**

He served in the Sixth Regiment under Capt. George Warley and was in the battle at Fort Moultrie. In addition, he was in the First Regiment and served in both from 10 June 1777 to 1 July 1781. He was a corporal, sergeant-major and lieutenant from 8 March 1779 to 1 July 1781. At the fall of Charleston, he was captured. He was in the siege of Savannah and the battle at Stono. N.A.246; N.A.859; N.A.853; A.A.497.

### **Bireau, \_\_\_\_\_**

He served as a captain during 1779. (A.A.6559); (Bouchillon, Joseph).

### **Birmingham, James**

He served two hundred four days in the militia under Capt. George Lidell during 1780 and 1781. A.A.500; I611; C.S.

### **Bishop, Abraham**

See Abraham Bushop.

### **Bishop, Bowling**

He served in the militia under Col. Robert Anderson. A.A.503; S377.

### **Bishop, Edmond**

He served with William Bishop, his brother. N.A.246.

### **Bishop, Edmond**

He served as a private and lieutenant in Roebuck's regiment before and after the fall of Charleston. C.S.; A.A.504; X732. (See Edmund Bushop).

### **Bishop, George**

He served forty-one days on horseback under Col. Winn and Gen. Marion during 1781. C.S.; A.A.505; Y52.

### **Bishop, Henry**

He served as a captain and was killed at Hanging Rock. (Bishop, Nicholas, S17847); Annuitants Claims; 9VV59.

### **Bishop, James**

He served under Capt. Jacob Barnett, Colonel Henry Hampton, and Gen. Sumter. A.A.506A; M313.

### **Bishop, John**

From 22 April 1781, he served as a horseman under Capt. Robert Cooper and from 11 February 1782, he served as a footman in the same unit. A.A.507.

### **Bishop, John**

S9279

Although he was only 15 or 16 when Charleston fell, as the British crossed the state, he and four brothers retreated from Chester District to North Carolina. On the morning before Huck's defeat they met troops near the Old Nation Ford on the Catawba River. He and his older brother Henry, who became a captain, joined the troops in attacking the British. Thereafter, he joined Col. Lacey and Gen. Sumter in the Indian lands and was in this unit until after the battle at Hanging Rock where his brother Henry was mortally wounded. He took the wounded to Charlotte. Next, he joined Capt. Miller's company after Gates's and Sumter's Defeats. Cold weather caused him to return home for clothes, where he was

captured by Capt. Elder and his Tory band. After being carried to Cary's Fort near Camden and held prisoner for two months, he escaped and found Sumter near the Catawba River. He was under Capt. Hugh Whitesides and later under Col. Henry Hampton and was at the siege of Thompson's Fort. In addition, he was guarding baggage at the battle at Eutaw Springs and was in the skirmish at Biggin Church. In 1782, he was again in Col. Lacey's regiment.

**Bishop, Nocholas** S17847

He entered service from Chester District, having volunteered at age 16 as a foot soldier and was placed under Capt. Hugh Whitesides. His second tour of duty was under Lt. Robert Cooper. After the fall of Charleston, he served under his brother, Capt. Henry Bishop and joined Sumter at Clem's Branch. He was in the battles at Rocky Mount and Hanging Rock, where his brother was killed. Next, he was under the command of Maj. Dixon and was at Sumter's Defeat. A.A.507½; Y1588.

**Bishop, Robert**

He served as a horseman in the militia from 6 June 1781 to 24 January 1782. C.S.; A.A. 507A; Z432.

**Bishop, Samuel**

He served in the militia under Col. Anderson. A.A.508; S376; C.S.

**Bishop, Thomas**

He served in the militia under Col. Brandon after the fall of Charleston. A.A.509; X2754; C.S.

**Bishop, William** W9356

b. 26 March 1760, Greenville, N. C.

d. 22 February 1836

While residing in Fairfield District, he enlisted during March 1779 under Capt. John Moore and Col. Winn and was in the battle at Stono. He re-enlisted during October 1780 under Capt. Murray and Col. Grimes of North Carolina. He was in the battle at Cowpens. Next, he joined Col. Dixon's North Carolina regiment.

**Bishop, William** S30275

He served under Capt. McClure and Col. Bratton and was in the battle at Cowpens. In addition, he was in the battles at Rocky Mount and Hanging Rock, where his brother, Capt. Henry Bishop, was killed.

**Bishop, William**

He served three hundred fifty-six days in the militia during 1779, 1780, 1781 and 1782. A.A.804; P596.

**Black, Adam**

He served in Col. Water's regiment after the fall of Charleston. C.S.; A.A.510A; X2458.

**Black, Alexander**

He served in the militia during 1780. X954; C.S.

**Black, Gavin**

He served forty-six days under a Capt. Meek and twenty-eight days under Lt. James Wilson. A.A.510A; I141; C.S.

**Black, George**

He served in the militia under Col. Bratton. A.A.511.

**Black, Guyan**

He served as a lieutenant in the militia during 1780. (Wright, Henry).

**Black, Jacob**

He served thirty days under Captain John Moffett and Col. Brandon. A.A.512; X955; C.S.

**Black, Jacob** S9281

b. 1756, Pa.

He moved to York District and, while residing on Broad River near Pinckneyville, enlisted under Capt. Black and Col. Watson of the militia. He was at Fair Forest under Captain Thomas Kirkpatrick and Maj. Ross against the Tories. Afterwards, he was drafted and sent on an expedition into Georgia and was in the battle at Briar Creek under Lt. Col. Samuel Watson. In 1779, he was drafted again and sent to Charleston under Black and Watson. In June 1780, he volunteered under Captain George Hodges and Maj. McDaniel of North Carolina. In August 1780, he volunteered under Sumter and Col. Campbell and was sent against the Tories at Smith's Ford. This prevented his being at the battle at Kings Mountain. In addition, he was in the battle at Blackstock's Plantation under Capt. James Jamieson and Gen. Sumter. In December 1780, he volunteered under Capt. William McCulloch as a guard over twenty-four wagons going to New Bern, North Carolina, to get stores for Sumter. Cornwallis turned them back. In May 1780, he volunteered under Kirkpatrick and Bratton and was at the siege of Friday's Fort. He volunteered in July 1781 under Capt. Woods and Col. Bratton and was in a skirmish at Six Mile House. In June 1782, he volunteered under
